**BE IT RESOLVED BY THE COMMITTEE ON RULES I MINA'TRENTA NA LIHESLATURAN GUÅHAN:**

**WHEREAS**, the missions of the University of Guam Endowment Foundation and the American Red Cross, Guam Chapter are helped through the contributions of the local community; and

**WHEREAS**, both non-profit organizations have teamed up to bring one of the Republic of the Philippines’ most celebrated fashion designers: Inno Sotto; and

**WHEREAS**, hailed as “Manila’s Prince of Fashion,” Mr. Sotto’s illustrious career includes runway shows in Paris and a Gold World Medal at the 2009 New York Festivals for the documentary about his life; and

**WHEREAS**, this is a rare opportunity for the local community to be exposed to this caliber of fashion design, while also giving financial contributions to two worthy causes; now therefore, be it
