BE IT RESOLVED BY I LIHESLATURAN GUAHAN:

WHEREAS, Esther Leon Guerrero Keone started her career with the Guam Department of Educating on August 1985 and her first teaching position was assigned to Yigo Elementary School (renamed Daniel L. Perez Elementary School) as a 5th Grade Teacher where she taught for seven (7) years; and

WHEREAS, after teaching her first seven years, Esther Leon Guerrero Keone was transferred to Harmon Loop Elementary School (renamed J. M. Guerrero Elementary School), then to Chief Brodie Elementary and then to Maria A. Ulloa Elementary School; and

WHEREAS, after eighteen (18) years of teaching and classroom instructions, Esther Leon Guerrero Keone in 2003, was assigned to be a School Program Consultant, a position she held for seven (7) years; and

WHEREAS, as a School Program Consultant, Esther was charged with the responsibility of developing the summer school standard operating procedures. In addition, Esther was instrumental in the compilation of the District Action Plan and served as co-chairperson of the Standards and Assessment Committee. Always wanting to better the education system, Esther helped to conduct the Math alignment for the elementary school level. She also conducted the training for substitute teachers on lesson planning and classroom management. Esther also wrote and carried out activities of the summer school program; and
