



12 Month Award for December 1999 and July 1996, Outstanding Work Center of the
13 Quarter in January 2000, October 2001, and October 2004, and 20 years of service
14 award in 2004; and

3 **WHEREAS**, Timmy Cordero will be sorely missed and all his colleagues and
4 friends wish him the best as he pursues his interests during his well deserved retirement;
