3 WHEREAS, Ray Mendiola Purugganan was born on January 17, 1953. His  
4 parents are Jesusa Mendiola and Steve Purugganan ; and

6 WHEREAS, Ray M. Purugganan currently resides in the village of Maina.  
7 He is married to Barbara Celestial Purugganan and is the proud father of  
8 Roland Paul, Rebecca Therese, Renessa, and Reyna; and

10 WHEREAS, Mr. Purugganan is a graduate of George Washington High  
11 School in Mangilao . He received a recognition in June 3, 1974 for his  
12 Outstanding Performance in the GED Test; and

1 **WHEREAS**, He began his professional career as General Helper with the  
2 Department of Law on February 1, 1973 until he transferred to the  
3 Department of Labor as General Helper on July 28, 1974 ; and

5 **WHEREAS**, On January 19, 1978, Ray Purugganan started working with  
6 the Department of Public Health and Social Services as Building Custodian  
7 II ; and

9 **WHEREAS**, On July 1, 1980, Mr. Purugganan was re-classified as  
10 Maintenance Worker and was reinstated on July 19, 1985 after he resigned  
11 from his post on July 12, 1985; and

13 **WHEREAS**, Ray M. Purugganan was promoted as Maintenance Specialist  
14 on October 1, 1985 and resigned from his post on October 2, 1996 ; and

16 **WHEREAS**, He returned as Maintenance Specialist with the Department of  
17 Public Health and Social Services on October 28, 1996; and

19 **WHEREAS**, Ray Purugganan was promoted on December 1, 1997 as  
20 Building Maintenance Supervisor. He received the Employee of the Year  
21 Award from the Department of Public Health and Social Services in  
22 January 1992; and

24 **WHERAS**, Ray Purugganan has assisted countless numbers of people  
25 during his 32 years in service as an employee of the government of Guam;  
26 now therefore be it;
