WHEREAS, in her role as a public servant, Senator Silva Taijeron was a steadfast supporter of Guam's public safety agencies, working with the Office of *I Maga'lahen Guåhan* to pay past due overtime payments to Officers of the Department of Corrections and the Guam Police Department; and
