WHEREAS, Preciosa Reyes Ulloa was born on October 24, 1910, in the

WHEREAS, being the eldest child of six children, Preciosa had many

responsibilities growing up and she naturally fell into the role as a caregiver, as

well as being seen as a mother figure because she worked tirelessly to ensure that

2 everyone in her family was fine by attending to their individual needs; and

WHEREAS, Preciosa married Felix Taitague, and they had two children together: †Josefa and David; and

WHEREAS, after the passing of her first husband at an early age, Preciosa married Mr. Vicente Castro in 1945, and together they had five children: Joseph,

†Frank, †Pedro, Arthur and Maria; and

WHEREAS, as a mother, Preciosa loved and provided for the physical and emotional needs of her children. Even as her children became adults, Preciosa always felt obliged to continue loving and caring for them; and

WHEREAS, despite Preciosa's second marriage ending in a divorce in 1977, she was there to care for her former husband on the weekends when he was gravely ill with cancer, which demonstrated her caring and forgiving nature; and

WHEREAS, Preciosa is described as very neat and organized as evidenced by her choice of work, and she was not one to complain. She took it upon herself to ensure that things were done properly. She worked hard and took pride in the quality of the work that she produced. She had worked as a housekeeper for the late Governor Carlos G. Camacho; and then later, for his brother, Luis Camacho, who lived in Windward Hills; and

WHEREAS, in 1994, while at work, Preciosa experienced a stroke and she fell and injured her head. As a result of the stroke, Preciosa's independence was affected in the healing process; and

WHEREAS, at that time, Preciosa's medical doctor predicted that she possibly had 6 months to live. Given the nature of Preciosa's health, the family felt that it was in the best interest of Preciosa to receive the required care at Saint Dominic's Senior Care Home. To this date, almost 19 years later, Preciosa has

1	lived beyond the life expectancy that her doctor had predicted, and her family is
2	looking forward to celebrating her 103 rd birthday on October 24, 2013; and

WHEREAS, Preciosa's longevity was attributed to her taking good care of herself, and her daily walks to the *San* Miguel Catholic Church for prayers before the 7:00 a.m. mass in *Talofofo*; and

WHEREAS, Preciosa's devotion to her faith and her dedication to her family is evident today, as she is blessed with 40 grandchildren, 40 great grandchildren, 18 great-great grandchildren, and two great-great grandchildren; and

WHEREAS, people who have known Preciosa would describe her as a very simple, patient, graceful, devoted, and quiet woman who dedicated her life to her faith, family and work; now therefore, be it
