WHEREAS, PhilMD will provide services to patients with or without medical insurance. However, patients with medical insurance may only facilitate requests in coordination with health insurance companies on Guam; and

WHEREAS, St. Luke's Medical Center continues to provide support and further its initiatives in serving the people of Guam by providing them with quality health care, which initiated the inception of the Philippine Medical and Dental Services, Inc. PhilMD will serve as a medical referral office which will extend their services with no fees required, such as providing opportunities to arrange transportation to and from the airport and the St. Luke's Medical Center Global City and Quezon City; and

WHEREAS, St. Luke's Medical Center has created a relationship with the physicians, patients, and their family members, here on Guam. Due to the lack of certain specialists and the inadequate equipment in Guam's health care facilities, the people of Guam continue to seek medical care off-island; and among the destinations of choice includes the Philippines due to its geographic location, as well as its reputation of having outstanding medical specialists; and
