WHEREAS, Rebecca's parents, Carlos and Rosemarie Takano, had owned and operated the Carl Rose Duty Free Store, from the 1960s through the 1980s; and in the 1990s, they opened Nina Ricci, a French luxury brand boutique located in the Tumon Sands Plaza; and

WHEREAS, in 1997, Rebecca Takano-Garcia and Jose Garcia had the franchise rights and opened a Gianfranco Ferrer Boutique, an Italian luxury brand; but in 2005, they closed the shop due to the decline in tourist spending; and

WHEREAS, in 2008, Kathy Sorensen wished to retire in Hawaii; and knowing of Kathy Sorensen's wishes to sell her furniture business, Rebecca Takano-Garcia and Jose Garcia decided that they wanted to get back into the retail business, and after many negotiations, the Designers Direct Furniture business became theirs; and

WHEREAS, since 2008, Rebecca Takano-Garcia and Jose Garcia have provided quality services and furniture products to the people of Guam; and
