| 3  | WHEREAS, to many radio listeners on Guam, Jon A. Anderson will fondly be               |
| 4  | remembered as the person who ushered in the concept of talk radio, serving as the host |
| 5  | of the popular K-57 "Breakfast Show" for twenty years. His morning radio program       |
| 6  | allowed listeners to call in and discuss various topics of interest within our         |

| 8  | WHEREAS, during his time at SMG, Jon A. Anderson also served as the                    |
| 9  | General Manager, and as a corporate executive, as the company expanded its             |
| 10 | operations into the CNMI. Additionally, Jon anchored the first television news         |
| 11 | broadcast of the Pacific News Center, the news program formed under SMG; and           |
| 12 | WHEREAS, after leaving Sorensen Media Group, Jon A. Anderson became a                  |
| 13 | Loan Officer for Bridge Capital, LLC, in December 2006, and he was assigned to         |

| 15 | Executive, and served in that capacity until June 2010; and                            |

| 17 | when he was named as the Editor-in-Chief of the Marianas Variety Guam Edition, in      |
