## BE IT RESOLVED BY THE COMMITTEE ON RULES OF I

- 2 MINA TRENTAI DOS NA LIHESLATURAN GUÅHAN:
- WHEREAS, the Most Reverend Bishop Enrico dal Covolo, SDB, was born

1 in Feltre, Italy. In Albaré, Enrico dal Covolo made his novitiate and took his first

2 vows on October 2, 1973. At the age of twenty-nine, Enrico dal Covolo was

3 ordained to the priesthood in Milan, Italy, on December 22, 1979, as a Salesian of

4 Saint John Bosco; and

WHEREAS, in 1986, then Father Enrico dal Covolo was transferred to the Vice Province of the Salesian Pontifical University in Rome; and in the following years, Father Enrico dal Covolo held a number of academic appointments, including, Professor of ancient Christian literature and a specialist in the Fathers of the Church; Dean of the Faculty of Literature, from 1993 to 2000; and from 2000 to 2003, he served as the Vice-Rector of the Salesian Pontifical University; and

WHEREAS, in 2003, Father dal Covolo was appointed by the Rector Major of the Salesians, Father Pascual Chávez, to serve as the Postulator General for the Causes of Saints of the Salesian Family, with Father dal Covolo becoming the second Salesian on the Commission for Sacred Archaeology; and he was confirmed to serve for an additional five year period; and

WHEREAS, on June 30, 2010, Father dal Covolo was appointed to serve as Rector Magnificus of the Pontifical Lateran University, replacing Archbishop Salvatore Fisichella; and

WHEREAS, in recognition of his new responsibilities as the Pontifical Lateran University's Rector, Father dal Covolo was appointed as Titular Bishop of *Heraclea* on September 15, 2010. Tarcisio Cardinal Bertone, SDB, Cardinal Secretary of State, was the Principal Consecrator at the Episcopal Ordination; and

WHEREAS, on September 18, 2012, Bishop dal Covolo was appointed by Pope Benedict XVI to serve as one of the Papal appointed Synod Fathers. As a non-diocesan ordinary, but still an episcopal member, he represented the

- 1 University for the October 2012, 13th Ordinary General Assembly of the Synod of
- 2 Bishops on the New Evangelization; and
- WHEREAS, Bishop dal Covolo is a Member of the Pontifical Committee
- 4 for Historical Sciences; a Consultor of the Congregation for the Doctrine of the
- 5 Faith; a Member of the Commission dealing with dispensations from priestly
- 6 obligations; and a Consultor of the Congregation for the Clergy; and
- WHEREAS, from December 21 to 29, 2013, the Most Reverend Bishop
- 8 Enrico dal Covolo, SDB, Rector of the Pontifical Lateran University in Rome,
- 9 made an official visit to the Blessed Diego Luis de San Vitores Catholic
- 10 Theological Institute for Oceania located at the Redemptoris Mater Archdiocesan
- 11 Missionary Seminary of Guam in Yoña. Accompanying Bishop dal Covolo is his
- 12 Secretary, Professor Father Mirko Integlia; and
- WHEREAS, the Redemptoris Mater Seminaries are a fruit of the renewal
- 14 called forth by the Second Vatican Council, with Blessed Pope John Paul II
- establishing the first Redemptoris Mater Seminary (RMS) for the Diocese of Rome
- in 1987; and since then, many Bishops from around the globe have followed the
- 17 example of the Holy Father by opening Redemptoris Mater Seminaries; and
- 18 WHEREAS, in 1999, the Most Reverend Archbishop Anthony Sablan
- 19 Apuron, OFM, Cap. D.D., Metropolitan Archbishop of Guam, and the then
- 20 President of CEPAC, erected the first ever Major Seminary on Guam, and named
- 21 the "Redemptoris Mater" in response to the late Holy Father Blessed Pope John
- 22 Paul II's call to the New Evangelization; and
- WHEREAS, in the same year, the Blessed Diego Luis de San Vitores
- 24 Catholic Theological Institute for Oceania, located at the Redemptoris Mater
- 25 Seminary premises, was erected; and

1 WHEREAS, in 2000, Archbishop Apuron, together with the pastoral team 2 of the Seminary, met with Monsignor Angelo Scola, the then Rector of the Pontifical Lateran University in Rome (now Patriarch of Venice), to start the 3 4 process for the affiliation of a Theological Institute to this renowned Pontifical 5 University; and 6 WHEREAS, in 2007, the Blessed Diego Luis de San Vitores Catholic Theological Institute for Oceania received its affiliation to the Pontifical Lateran 7 University, commonly known as "The Pope's University" in Rome. In 2012, after 8 9 five years ad experimentum, the affiliation was renewed; and 10 WHEREAS, there are forty-two Seminarians from twenty nations training 11 for the Sacred Priesthood at the Seminary in Yoña, and all their studies are 12 completed at the Blessed Diego Luis de San Vitores Catholic Theological Institute 13 for Oceania, which functions on the grounds of the Seminary; and 14 WHEREAS, each Seminarian, from day one, is introduced into a well-15 designed and balanced intellectual formation, including the study of philosophy 16 (three years) and theology (four years); and other complementary literary and 17 scientific disciplines, such as languages, research techniques, history, catechetics, 18 Sacred Scripture, and liturgy; and 19 WHEREAS, thirteen priests who were ordained for the Archdiocese of 20 Agaña have completed their studies in Sacred Theology at the said Institute, and 21 twelve of the priests have received their Bachelor's Degree in Sacred Theology 22 from the Institute; now therefore, be it 23 **RESOLVED,** that the Committee on Rules of I Mina Trentai Dos Na Liheslaturan Guåhan does hereby, on behalf of I Liheslaturan Guåhan and the 24 25 people of Guam, recognize and honor the Most Reverend Bishop Enrico dal
