- 7 made his Solemn Perpetual profession on September 1, 1959; and four years later,
- 8 he was ordained into the Priesthood on January 11, 1964; and

- 10 he was appointed to study the Japanese language in Tokyo, Japan, and assigned to
- an Okinawa Mission on August 31, 1964. Father Gordon's love for the Lord Jesus

- 5 Hawaiian Islands. His ministering has truly been significant in strengthening the
