The Bureau requests that Bill No. 185-35 (COR) be granted a waiver pursuant to Public Law 12-229 as amended for the following reasons(s):

Legislative Bill No. 185-35 is an act to amend § 70.01 through 70.11 of Article 1, Chapter 70, Title 9 and § 34111, Chapter 34, Title 10, Guam Code Annotated, and to amend § 3119 (a), Chapter 3, Title 9, Guam Administrative Rules and Regulations, and repeal §§ 34112, 34120, and 34205, Chapter 34, Title 10, Guam Code Annotated, and repeal §3116 (b) and (c), and Part 6, of Chapter 3, Title 9, Guam Administrative Rules and Regulations, relative to Establishing the Protecting Animal Welfare and Safety (PAWS) Act, also known as Pugua's Law.

Based on the foregoing, the provisions in Bill No. 185-35 are administrative in nature and would not fiscally impact the appropriations of FY 2019.
