Dear Mr. Speaker:

Transmitted herewith is Bill No. 829, which I have signed into law this date as Public Law No. 20-44.

The laudable intent of this measure to improve the sports and recreational facilities in Dededo is hampered by ambiguities in the descriptions of two of the facilities. In Section I, funds are appropriated for lighting improvements at the multi-purpose court adjacent to the Dededo Middle School. Just last week the lighting improvements to that court were finished. I assume that the legislature intended that the funds be used to improve the lighting at the other Dededo multi-purpose court which is located near the Playground for All Children.

In Section 2, funds are appropriated for a baseball field in Liguan Terrace. The Department of Parks and Recreation has determined that the appropriate site for the new baseball field is in the Harmon Loop Sports Complex adjacent to Liguan Terrace.

I request that the Legislature amend the law to provide:

"Section I. Thirty Thousand Dollars (\$30,000) are appropriated from fiscal year 1990 revenues to the Department of Public Works to make lighting improvements to the Dededo Multi-Purpose Court near the Playground for All Children park.

Section 2. Three Hundred Fifty Thousand Dollars (\$350,000) are appropriated from fiscal year 1990 revenues to the Department of Public Works for construction of a baseball field near Liguan Terrace, Dededo at the Harmon Loop Sports Complex."

In order to end fiscal year 1989 with a balanced budget, I request that the Legislature also amend Section 3 to indicate that the appropriation made in that section is from the fiscal year 1990 revenues.

BE IT ENACTED BY THE PEOPLE OF THE TERRITORY OF GUAM: Section 1. Thirty Thousand Dollars (\$30,000) are hereby appropriated from the General Fund to the Department of Public Works to make lighting improvements to the Dededo Multi-Purpose Court adjacent to the Dededo Middle School. Section 2.

Three Hundred Fifty Thousand Dollars (\$350,000) are hereby appropriated from the General Fund to the Department of Public Works for a baseball field in Liguan Terrace, Dededo.

Section 3. Four Hundred Thousand Dollars (\$400,000) are hereby appropriated from the General Fund to the Department of Public Works to make lighting improvements to "Hal's Angels" football and baseball fields.

Section 4. The Dededo Municipal Planning Council shall coordinate the projects authorized by this Act with the Department of Parks and Recreation and the Department of Public Works. The contracting officer for the projects shall be the Director of Public Works.

COMMITTEE REPORT ON BILL NO. 829

AN ACT TO APPROPRIATE FUNDS FOR IMPROVEMENT OF RECREATIONAL FACILITIES IN DEDEDO

BILL No. 829 WAS INTRODUCED ON JULY 3, 1989 BY SENATORS JOE T. SAN AGUSTIN, HERMINIA D. DIERKING, DON PARKINSON, TED S. NELSON, JOHN P. AGUON, ELIZABETH P. ARRIOLA, FRANKLIN J. QUITUGUA, EDWARD D. REYES, GORDON MAILLOUX, AND PILAR C. LUJAN (SEE EXHIBIT "A"). THE BILL WAS PUBLICLY HEARD BY THE COMMITTEE ON WAYS & MEANS ON JULY 25, 1989 IN THE LEGISLATIVE SESSION HALL. A FISCAL NOTE FROM THE BUREAU OF BUDGET & MANAGEMENT RESEARCH WAS RECEIVED ON THE MEASURE (SEE EXHIBIT "B").

BACKGROUND

BILL No. 829 APPROPRIATES \$780,000 FOR THE IMPROVEMENT OF RECREATIONAL FACILITIES IN DEDEDO. THIS SUM BREAKS DOWN AS FOLLOWS:

SECTION 1 - \$30,000 FOR LIGHTING IMPROVEMENTS AT THE DEDEDO MULTI-PURPOSE

COURT.

SECTION 2 - \$350,000 FOR A BASEBALL FIELD IN DEDEDO.
SECTION 3 - \$400,000 FOR LIGHTING IMPROVEMENTS AT HAL'S ANGELS FOOTBALL FIELD.


FURTHERMORE, SECTION 4 OF THE BILL MANDATES THE COORDINATION OF THESE PROJECTS WITH THE DEDEDO MUNICIPAL PLANNING COUNCIL, THE DEPARTMENT OF PARKS & RECREATION, AND THE DEPARTMENT OF PUBLIC WORKS.
