Enclosed please find a copy of Bill No. 26 (COR), "AN ACT TO AMEND ITEM (1), SUBSECTION (b) OF SECTION 63507 OF TITLE 5 GUAM CODE ANNOTATED, RELATIVE TO THE ELECTION AND TERM OF SOIL AND WATER CONSERVATION DISTRICT DIRECTORS.", which I have signed into law today as Public Law No. 24-09.

Presently, members of the Northern and Southern Soil and Water Conservation Districts may only run for this elected position 3 times. The terms are 3 years each. Although I am in favor of having as many persons as possible have the chance to serve as a member of one of the Soil and Water Conservation Districts, I believe that those who are voting for the members should be the ones to decide how long a member serves.

AN ACT TO AMEND ITEM (1), SUBSECTION (b) OF SECTION 63507 OF TITLE 5 GUAM CODE ANNOTATED, RELATIVE TO THE ELECTION AND TERM OF SOIL AND WATER CONSERVATION DISTRICT DIRECTORS.

BE IT ENACTED BY THE PEOPLE OF THE TERRITORY OF GUAM:

Section 1. Item (1), Subsection (b) of Title 5 Guam Code Annotated §63507 is hereby amended to read:

"(1) Farm land owners or occupiers of the districts shall nominate and elect five (5) nonpartisan directors from among their number. The first election shall be held within two (2) months after enactment of this Act; and commencing in 1985, elections shall thereafter be held on the second Tuesday in August. At the first election, one (1) director shall be elected for one (1) year, two (2) directors shall be elected for two (2) years, and two (2) directors shall be elected for three (3) years. Thereafter, commencing 1985, each director shall be elected for a term of three (3) years."
