



1        **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2        **Section 1. Appropriation to GPSS.** The sum of Five Million Two  
3        Hundred Thousand Dollars (\$5,200,000) is appropriated from the balance of the  
4        cash received from the Rural Telephone Bank (RTB) Stock Redemption held by  
5        the government of Guam to the Guam Public School System for its operations in  
6        Fiscal Year 2006.

1           **Section 2. Reporting Requirements.** The Superintendent of the Guam  
2 Public School System shall submit to the Speaker of *I Liheslaturan Guåhan* a  
3 report of all expenditures made from this appropriation.

4           **Section 3. Funds Reimbursement.** Any excess amount of funds received  
5 by the Guam Public School System greater than the One Hundred Sixty Million  
6 Fourteen Thousand Three Hundred Sixty-two Dollars (\$160,014,362.00)  
7 appropriation for its Fiscal Year 2006 operations shall first be used to reimburse  
8 the amount appropriated from the RTB Stock Redemption account hereunder. The  
9 remaining excess balance shall be used to reimburse the original fund sources from  
10 which funds were transferred to GPSS.


