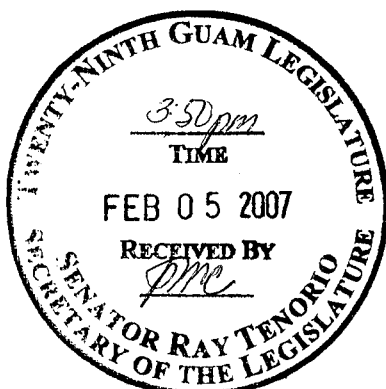





**AN ACT TO *ADD* A NEW §80126 TO CHAPTER 80 OF TITLE  
5 OF THE GUAM CODE ANNOTATED, RELATIVE TO  
AUTHORIZING THE GUAM PUBLIC LIBRARY SYSTEM TO  
PROCURE DSL AND CABLE LINES TO PROVIDE  
INTERNET ACCESS TO ITS EMPLOYEES AND PATRONS.**

1       **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2       **Section 1.** A new §80126 is hereby *added* to Chapter 80 of Title 5 of the  
3       Guam Code Annotated to read as follows:

1           **“§80126. Procurement of DSL, Cable and Wireless Broadband**  
2 **Services.**

3           The Guam Public Library System is authorized to procure, from private  
4 companies doing business on Guam, DSL (Digital Subscriber Lines) services,  
5 cable television/internet services and/or wireless broadband services as a means of  
6 providing internet access to its employees and patrons. In the procurement of such  
7 services, the Guam Public Library System shall consider the cost, the amount of  
8 bandwidth, and the reliability of the service. The Department of Administration  
9 shall *not* require the Guam Public Library system to use the Government of  
10 Guam’s data network to provide internet access to its employees and patrons.”
