

AN ACT TO *ADD* A NEW §80126 TO CHAPTER 80 OF TITLE 5 OF THE GUAM CODE ANNOTATED, RELATIVE TO AUTHORIZING THE GUAM PUBLIC LIBRARY SYSTEM TO PROCURE DSL AND CABLE LINES TO PROVIDE INTERNET ACCESS TO ITS EMPLOYEES AND PATRONS.

BE IT ENACTED BY THE PEOPLE OF GUAM:

Section 1. A new §80126 is hereby *added* to Chapter 80 of Title 5 of the
Guam Code Annotated to read as follows:

"§80126. Procurement of DSL, Cable and Wireless Broadband
 Services.

3 The Guam Public Library System is authorized to procure, from private 4 companies doing business on Guam, DSL (Digital Subscriber Lines) services, 5 cable television/internet services and/or wireless broadband services as a means of providing internet access to its employees and patrons. In the procurement of such 6 services, the Guam Public Library System shall consider the cost, the amount of 7 8 bandwidth, and the reliability of the service. The Department of Administration 9 shall not require the Guam Public Library system to use the Government of 10 Guam's data network to provide internet access to its employees and patrons."
