





1           **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2           **Section 1.** A new § 3218 is *added* to Article 2 of Chapter 3 of Title 16, Guam  
3 Code Annotated, to read as follows:

1           **“§3218. Applicability of Article for Government of Guam Owned**  
2 **Vehicles.** All provisions of this Article apply to vehicles owned by the  
3 government of Guam.”

4 **Section 2.** A new § 3607 is *added* to Article 6 of Chapter 3 of Title 16, Guam  
5 Code Annotated, to read as follows:

6           **“§3607. Applicability of Article for Government of Guam Owned**  
7 **Vehicles.** All provisions of this Article apply to vehicles owned by the  
8 government of Guam.”
