BE IT ENACTED BY THE PEOPLE OF GUAM:

- 2 Section 1. A new §849.4 is hereby *added* to Chapter 8, Article 1 of Title 1
- 3 of the Guam Code Annotated, to read as follows:

"§849.4. Gregory "Coach Greg" Andrew Matanane Memorial Baseball Complex. (a) The Department of Parks and Recreation Baseball Fields situated within the Dededo Sports Complex between the soccer field and the Dededo gymnasium is hereby named the Gregory "Coach Greg" Andrew Matanane Memorial Baseball Complex, to honor Greg Matanane who unexpectedly died on January 3, 2009.

7 (b) Any provisions in the statutes referencing the Department of
8 Parks and Recreation Baseball Fields situated within the *Dededo* Sports
9 Complex between the soccer field and the *Dededo* gymnasium are *amended*10 to read: *Gregory "Coach Greg" Andrew Matanane* Memorial Baseball
11 Complex.

I Maga'lahen Guåhan and the Director of Parks and Recreation 12 (c) 13 shall cause to be erected appropriate nameplates or signs designating the 14 Baseball Complex situated within the Dededo Sports Complex as the 15 Gregory "Coach Greg" Andrew Matanane Memorial Baseball Complex. 16 Further, at such ceremony as I Maga'lahi and the Director of Parks and Recreation deem appropriate, said Gregory "Coach Greg" Andrew 17 18 Matanane Memorial Baseball Complex shall be officially named and a plaque bearing the name, picture and brief history of the contributions of 19 Gregory "Coach Greg" Andrew Matanane shall be affixed within a suitable 20 21 spot on the above designated areas.

COMMITTEE REPORT DIGEST

I. OVERVIEW

The Committee on Municipal Affairs, Aviation, Housing, and Recreation convened a public hearing on Wednesday, October 14, 2009 at 9:00 a.m. in *I Liheslatura's* Public Hearing Room. Among the items on the Agenda was the consideration of Bill No. 245-30 (COR) – "An act to add §849.4 to Chapter 8 of Article 1 of Title 1 of the Guam Code Annotated naming the Baseball Complex situated within the Dededo Sports Complex in honor of Gregory "Greg" Andrew Matanane, and to name the four baseball fields within the complex in honor of Guam's pioneers of Little League Baseball on Guam", sponsored by Senator Edward J.B. Calvo.

Public Notice Requirements

Notices were disseminated via email to all senators/members and all main media broadcasting outlets on Friday, October 14, 2009 (5-Day Notice), and again on Monday, October 12, 2009 (48-Hour Notice) via a Memorandum from the Committee Chair and a Press Release.

Senators Present

Senator Tina Muña-Barnes, Chairperson Senator Frank F. Blas, Jr., Committee Member Senator Edward J. B. Calvo, Committee Member & Sponsor Senator Telo Taitague, Committee Member Senator Ray Tenorio, Committee Member Senator James Espaldon

The Public Hearing was called to order at 9:55 a.m.

II. SUMMARY OF TESTIMONY & DISCUSSION

The Committee on Municipal Affairs, Aviation, Housing, and Recreation heard testimonies from family and friends of the late deputy director of Parks and Recreation.

Senator Edward J. B. Calvo stated if Bill No. 245-30(COR) passes into law, the baseball complex within the Dededo Sports Complex between the Robbi Webber Soccer Field and the Dededo gymnasium will be named the Gregory "Greg" Andrew Matanane Baseball Complex. Senator Calvo added Mr. Matanane died earlier this year and it was he who spearheaded the construction of the baseball complex prior to his untimely death.

Senator Calvo further stated "Greg was a wonderful man, who dedicated his life to helping young people succeed. He and his family have done so much for Guam. "Greg was a guy who loved baseball, watched his kids play the game, and gave so much to others. This field was

Greg's vision and project. It is too bad he is not around to see its completion, because he would be proud. He was a role model for what a citizen should be, not only in his work, but also as a family man."

Senator Calvo concluded his comments emphasizing the baseball fields within the baseball complex also will be renamed in honor of Guam's little league baseball pioneers. Senator Calvo proposes to rename, if the bill passes:

- Baseball Field 1 to the "Commissioner Gregorio 'Greg' A. Calvo Little League Field"

- Baseball Field 2 to the "Commissioner Gregorio Borja Rookie League Field"

- Baseball Field 3 to the "Major Vicente 'Ben' Munoz (Guam Police Retired) Big League Field" and

- Baseball Field 4 to the "Francisco 'Frank' Aguon, Sr. Senior League Field

Mrs. Gloria Cruz Matanane, widow of the late Greg Matanane thanked the authors of the Bill for introduction of the legislation and Senator and Chairperson Tina Muña-Barnes and Committee members for conducting the public hearing.

Mrs. Matanane submitted written testimony attached stating "A complex of this magnitude has been a dream of Greg's for a long time. In 1997, he took a team of youth baseball players to Modesto, California and saw three fields, back-to-back, and said he wanted that for Guam. That was the start of his dream. Baseball was a passion for Greg. He wanted kids to have something to be proud of. On behalf of my children and our grandchildren, thank you very much."

Mr. Matanane's former colleagues in the administration and friends – Mr. Chris Dueñas and Mr. Joseph Dueñas also testified in favor of the bill.

Mr. Chris Dueñas thanked Senator Calvo, for introducing the legislation in honor of people who have done so much for baseball and Guam. Mr. Dueñas testified he got to know Greg's passion for kids over the years and this legislation is befitting and very appropriate to commemorate the years of service Greg gave to the children of Guam adding "He really did care about our island's youth." Greg in his capacity of leadership used all his energies to take a dream and see it through to be enjoyed by the island's youth for years to come.

Mr. Rick Ninete, a close friend of Mr. Matanane, spoke about Greg being instrumental in passion for the development of sports for the island whether it was baseball or tennis. He added "... there is lot to say about Greg Matanane." Mr. Ninete testified in favor of Bill 245-30 (COR) to memorialize Greg's and requested the support of the senators.

Mr. Joseph Dueñas, Mr. Matanane's friend and Department of Parks and Recreation Director gave an emotional account of Mr. Matanane's vision. Mr. Dueñas echoed Mr. Ninete's sentiment about Greg describing his character as an individual whose "actions speak louder than words". He recounted "I spent so much time with Greg, driving to the sports complex, and through the fields he envisioned". I just never thought this project would be finishing the fields without him. Greg would have preferred being here to see his vision of a four leaf clover field come to fruition as do his family and friends. Residents from all around the island will be able to use this complex – to include a swimming pool and a walking track which was a part of Greg's Vision" Mr. Dueñas thanked Senator Calvo for the introduction of Bill 245-30 (COR) and stated he is in full support of the legislation.

Responding to Senator James Espaldon's query for a briefing on funding of the complex, Mr. Dueñas reported initially \$250,000 from the National Park Service Water Conservation Fund which imposed multiple year suspension to access funding. Three (3) years ago, the Department of Parks and Recreation (DPR) was taken off suspension at which time Mr. Matanane pursued the development of the complex. Public Law 28-73 signed into law on November 15, 2005 authorized *I Maga'lahen Guåhan* to transfer the property to the Guam Little League Baseball, Incorporated for the purpose of constructing the Asia-Pacific Baseball Stadium to include the Little League Headquarters and Training Facility stipulating a two (2) year reversionary clause if property is not developed. The Little League of Guam was notified of the funding availability and agreed to allow for the construction of the four (4) fields.

Mr. Dueñas added DPR believes in the development of a fitness facility to address the nationwide increase of obesity cases. Greg Matanane worked with Guam Housing and Urban Renewal Authority (GHURA) Community Development Block Grant for the construction of a swimming pool facility as means to conduct preventative health concerns for our island residents. GHURA awarded \$2.5M for the project with the *I Maga'lahen Guåhan* approving the additional \$1M from Compact Impact Funds. The sports complex when completed will include a soccer field, the four baseball diamonds, a gymnasium, and a swimming pool facility.

Senator Espaldon was assured by Mr. Dueñas that the government was not in violation of any covenants, restrictions, and limitations of federal funding

Other senators also describe their experience with Mr. Matanane.

Senator Telo Taitague thanked Senator Calvo for introducing the legislation and those present testifying in support of Bill 245-30 (COR) adding the legislation is the greatest tribute to Greg Matanane. "He was a good man, a family man. What he did for Guam's children, to take them off the streets and give them good opportunities, is amazing." She further requested her name be included as a sponsor of the legislation and expressed her support on Bill 245-30 (COR).

Senator Ray Tenorio added "Many people, go through their entire lives with a vision and a passion to put into some tangible form their hopes and dreams. Greg had that vision and did something about it. Even after his passing, the fact that his family and his colleagues came together to see this project through, is a testament to Greg's sincerity and his character. Everything Greg did all his life was toward the betterment of the lives of children of Guam." Senator Tenorio assured Mrs. Matanane, her children, family and friends of his support on the legislation.

Senator Frank F. Blas, Jr. reminisced about a gathering at his residence with Mr. Greg Matanane and Mr. Chris Dueñas. "Greg was not a man of a whole lot of words but a man with a whole lot of passion. One word describes Greg – "please.""He put his heart and soul into a request which did not require justification or an explanation. This bill memorializes Greg. We want him to be remembered, not only by the people of Guam, but by the kids he helped, trained, and groomed." Senator Blas inquired of Mrs. Matanane if in the legislation Greg Mantanane can be referred to as "Coach Greg." Senator Blas thanked Senator Calvo for having a co-sponsor on Bill 245-30 (COR) and also thanked Senator Muña-Barnes for the swift scheduling of the hearing.

Senator Calvo closing remarks remembered Mr. Greg Matanane as the exemplification of the Chamorro style "quiet dignity" and getting the job done. He added Greg's greatest fan was his wife Lola and their children. His work ethic, service to the community, a coach, and as a parent embodies Greg as a role model of all that is good in our community. Senator Calvo asked for the support of his colleagues.

Senator Muña-Barnes remembered Mr. Matanane for his smile or a tap on the shoulder. She described him as one of the unsung heroes whose commitment and passion was to keep the children of Guam off the streets.

Senator Espaldon acknowledge Mayor Ben Gumataotao and queried Mr. Joe Dueñas whether the \$4M awarded to the Department of Parks and Recreation will include baseball field repairs for Piti, Talofofo, Inarajan, and other villages who also need their baseball fields fixed up. Mr. Dueñas replied the GHURA Community Development Block Grants are project specific and advised the mayor's are eligible to apply for the grants.

Senator Calvo inquired on the completion date for the fields. Mr. Dueñas answered the fields should be completed within the next month notwithstanding rain delays and receipt of the additional funding from the Compact Impact funds.

Senator Muña-Barnes reiterated the Committee will continue to receive testimony for the next ten (10) days at her office at 155 Hesler Place, *Hagåtña* or via email/fax. There being no further discussion or testimony, Senator Muña-Barnes adjourned the hearing at 10:47 a.m.

A complex of this magnitude has been a dream of Greg's for a long time. In 1997, he took a team of young baseball players to Modesto, California. It was there that he first saw three fields back-to-back. He was so excited and was always talking about such plans.

Then in February 2007, he visited such a complex when he attended meetings with officials from Hawaii's Department of Parks and Recreation. Then he had a plan, and he was in the position as the Deputy Director of Guam's Department of Parks and Recreation to make a dream come true.

In May, 2008, our youngest son flew us over Honolulu. Greg made our son fly over that complex three times as he would shoot away, taking pictures. He had those pictures posted in his office and he was so proud.

He would tell me all about the progress of the plans for the complex. He was so excited in anticipation of its completion this year.

He wanted to have a great field, back-to-back, just like what he saw many years ago.



AN ACT TO *ADD* §849.4 TO CHAPTER 8 OF ARTICLE 1 OF TITLE 1 OF THE GUAM CODE ANNOTATED NAMING THE BASEBALL COMPLEX SITUATED WITHIN THE DEDEDO SPORTS COMPLEX IN HONOR OF GREGORY "GREG" ANDREW MATANANE, AND TO NAME THE FOUR BASEBALL FIELDS WITHIN THE COMPLEX IN HONOR OF GUAM'S PIONEERS OF LITTLE LEAGUE BASEBALL ON GUAM.

BE IT ENACTED BY THE PEOPLE OF GUAM:

Section 1. §849.4 is hereby *added* to Chapter 8, Article 1 of Title 1 of the
Guam Code Annotated to read as follows:

4 "§849.4. Gregory "Greg" Andrew Matanane Baseball Complex.
5 The Department of Parks and Recreation Baseball Complex situated
6 within the Dededo Sports Complex between the Robbi Webber Soccer
7 Field and the Dededo gymnasium is hereby named the *Gregory "Greg"*8 Andrew Matanane Baseball Complex who unexpectedly died on January
9 3, 2009. There shall be at the entrance at an appropriate place on the

field a plaque so honoring *Gregory "Greg" Andrew Matanane* and the complex shall be so named by *I Maga'lahen Guåhan*, the Department of Parks and Recreation, and the Mayor of Dededo in such commemorative ceremony as the deem appropriate following the approval hereof.

6 (b) Any provisions in the statutes referencing the Department of 7 Parks and Recreation Baseball Complex situated within the Dededo 8 Sports Complex between the Robbi Webber Soccer Field and the 9 Dededo gymnasium are amended to read: *Gregory "Greg" Andrew* 10 *Matanane* Baseball Complex.

11 (c)The Governor of Guam and the Director of Parks and 12 Recreation shall cause to be erected appropriate nameplates or signs 13 designating the Baseball Complex situated within the Dededo Sports 14 Complex as the Gregory "Greg" Andrew Matanane Baseball Complex. 15 Further, at such ceremony as the Governor and the Director of Parks 16 and Recreation deem appropriate, said *Gregory "Greg"* Andrew Matanane 17 Baseball Complex shall be officially named and a plaque bearing the 18 name, picture and brief history of the contributions of Gregory "Greg" Andrew Matanane shall be affixed within a suitable spot on the above 19 20 designated areas.
