



BE IT ENACTED BY THE PEOPLE OF GUAM:

Section 1. § 51502 of Article 5, Chapter 51 of Division 2, Title 10, Guam Code Annotated, is hereby *amended* to read:

“§ 51502. Recycling Revolving Fund.

There is hereby created the Recycling Revolving Fund (Fund), which *shall* be maintained separate and apart from any other funds, including the

1 General Fund of the government of Guam, and independent records and
2 accounts *shall* be maintained thereof. All revenue generated from recycling
3 fees collected pursuant to this Article, including interest earned, *shall* be
4 deposited into the Recycling Revolving Fund. The funds deposited into the
5 Recycling Revolving Fund *shall not* be subject to the transfer authority of *I*
6 *Maga'lahaen Guåhan.*”

I. OVERVIEW

BILL NO. 282-31 (COR) - "AN ACT ADD AMEND § 51502 OF CHAPTER 51, OF DIVISION 2 OF TITLE 10, GUAM CODE ANNOTATED; RELATIVE TO EXEMPTING THE GUAM RECYCLING FUND FROM THE TRANSFER AUTHORITY OF I MAGA'LAHEN GUÅHAN" was introduced by Senator Tina Muña Barnes on August 8, 2011; and was subsequently referred to the Committee on Rules; Federal, Foreign & Micronesia Affairs; and Human and Natural Resources on August 9, 2011.

Senator Rory J. Respicio, Chairperson of the Committee on Rules; Federal, Foreign & Micronesia Affairs; and Human and Natural Resources convened a public hearing on Bill 282 on Friday, October 7, 2011 at 2:00 P.M. in the Legislature's Public Hearing Room to receive public testimony on the measure.

Public Notice Requirements

In accordance with the Open Government Law, notices were disseminated to all senators and to all main media broadcasting outlets, first on September 30, 2011, and again on October 5, 2011.



6 which shall be maintained separate and apart from any other funds,
7 including the General Fund of the government of Guam, and independent
8 records and accounts shall be maintained thereof. All revenue generated
9 from recycling fees collected pursuant to this Article, including interest
10 earned, shall be deposited into the ‘Recycling Revolving Fund’, hereinafter
11 in this Article referred to as the ‘Fund’. All funds deposited into the
12 Recycling Revolving Fund shall not be subject to the transfer authority of *I*
13 *Maga'lahen Guåhan*
