





**AN ACT TO AMEND §79301 OF ARTICLE 3, CHAPTER
79 OF TITLE 21, GUAM CODE ANNOTATED,
RELATIVE TO EXPANDING THE REPRESENTATION
ON THE *HAGÅTÑA* RESTORATION &
REDEVELOPMENT AUTHORITY, TO INCLUDE THE
MAYOR OF *HAGÅTÑA* AND A LEGISLATIVE
REPRESENTATIVE, AND FOR OTHER PURPOSES.**

1 **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2 **Section 1.** §79301 of Article 3, Chapter 79 of Title 21, Guam Code
3 Annotated, relative to the Establishment provisions of the *Hagåtña* Restoration and
4 Redevelopment Authority, is hereby *amended* to read as follows:

1 “§ 79301. Establishment.

2 There is within, a public corporation and autonomous instrumentality
3 of the government of Guam, the “*HAGĀTÑA RESTORATION &*
4 *REDEVELOPMENT AUTHORITY.*” The powers, rights, privileges,
5 functions and duties of the Authority *shall* be vested in nine (9)
6 Commissioners, selected in accordance with the provisions in this Section.
7 Seven (7) Commissioners *shall* be appointed by *I Maga’låhi* (the Governor),
8 with the advice and consent of *I Liheslaturan Guåhan* (the Guam
9 Legislature), to serve for a term of five (5) years. The eighth and ninth
10 Commissioners *shall* be selected as follows: one of the Commissioners *shall*
11 be the Mayor of *Hagåtña*, who shall serve for the duration of his/her term(s);
12 one (1) member *shall* be appointed by the Speaker of the Guam Legislature,
13 who *shall* serve at the pleasure of the Speaker, and whose appointment *shall*
14 be effective until the conclusion of the term of the Guam Legislature in
15 which he/she was appointed.

16 (a) Before taking office or entering on duty, each Commissioner, as
17 well as each employee of the Authority, *shall* take the oath of office required
18 of all officers and employees of the government of Guam.

19 (b) Any Commissioner appointed by the Governor may be
20 removed by the Governor for inefficiency, neglect of duty or misconduct in
21 office, after a hearing before the Governor or a hearing officer specially
22 designated by him for the purpose.

23 (c) A Commissioner shall receive no compensation for his services,
24 but *shall* be entitled to payment of official travel costs and reimbursement of
25 expenses actually and necessarily incurred in the discharge of his duties and
26 functions.

(d) The Governor *shall* designate a Chairman and Vice-Chairman from among the Commissioners. The Commissioners *shall* constitute the Board of Commissioners of the Authority. The Board may employ an Executive Director of the Authority who *shall* serve at the pleasure of the Board, technical experts, such other officers, agents and employees, permanent and temporary, as it may deem necessary, and *shall* determine their qualifications, duties, tenure and compensation. For such legal services as it may require, the Authority may employ or retain its own counsel and legal staff. The Authority may delegate to one (1) or more of its officers, agents or employees, such powers and duties as it may deem proper. The Board *shall* adopt personnel rules pursuant to Title 4, Guam Code Annotated, §§ 4105 and 4106.

(e) Five (5) Commissioners *shall* constitute a quorum of the Board of Commissioners of the Authority for the purpose of conducting the business of the Authority and exercising its powers, and for all other purposes. A vote of the majority of the Commissioners present at any meeting of the Board *shall* prevail.

(f) Non-voting ex-officio members *shall* include representatives from the Department of Parks and Recreation, the Richard F. Taitano Micronesia Area Research Center, the *Chamorro* Language Commission, the Guam Visitors Bureau, the Department of Integrated Services for Individuals with Disabilities (DISID), the Department of Land Management, the Department of Public Works, the Guam Environmental Protection Agency, and the Guam Preservation Trust. These members *shall* provide technical assistance to ensure accuracy in the development of the Plan.”

Section 2. Effective Date. The provisions contained herein *shall* be effective upon enactment of this Act.



BE IT ENACTED BY THE PEOPLE OF GUAM:

Section 1. §79301 of Article 3, Chapter 79 of Title 21, Guam Code Annotated, relative to the Establishment provisions of the *Hagåtña* Restoration and Redevelopment Authority, is hereby *amended* to read as follows:

1 **“§ 79301. Establishment.**

2 There is within, a public corporation and autonomous instrumentality
3 of the government of Guam, the “*HAGĀTÑA RESTORATION &*
4 *REDEVELOPMENT AUTHORITY.*” The powers, rights, privileges,
5 functions and duties of the Authority *shall* be vested in nine (9)
6 Commissioners, selected in accordance with the provisions in this Section.
7 Seven (7) Commissioners *shall* be appointed by *I Maga’låhi* (the Governor),
8 with the advice and consent of *I Liheslaturan Guåhan* (the Guam
9 Legislature), to serve for a term of five (5) years. The eighth and ninth
10 Commissioners *shall* be selected as follows: one of the Commissioners *shall*
11 be the Mayor of *Hagåtña*, who shall serve for the duration of his/her term(s);
12 one (1) member *shall* be appointed by the Speaker of the Guam Legislature,

The Bill is administrative in nature in that it proposes to amend §79301 of Article 3, Chapter 79, Title 21 GCA relative to expanding the representation on the Hagatna Restoration & Redevelopment Authority. Cruz and was subsequently referred by the Committee on Rules to the **Committee on Municipal Affairs, Tourism, Housing and Hagåtña Restoration & Redevelopment Authority** on **April 22, 2013**.

The **Committee on Municipal Affairs, Tourism, Housing and Hagåtña Restoration & Redevelopment Authority** convened a public hearing on **Bill No. 96-32(COR)** on **Tuesday, May 14, 2013 at 9:00 AM** at the Legislature's Public Hearing Room in Hagåtña.

II. INTRODUCTION, SUMMARY OF TESTIMONY & DISCUSSION

Senator Muna Barnes: Next on the Agenda ladies and gentlemen is **Bill No. 96-32 (COR)** An act relative to expanding the representation on the Hagåtña Restoration & Redevelopment Authority, to include the Mayor of Hagåtña and a Legislative Representative, amending §§79301 of Article 3, Chapter 70, Title 21, GCA. I do have here to speak is the President of the Department of Chamorro Affairs Mr. Joseph Cameron. If anyone else wishes to speak, please sign-up at the table to my left. At this time I'll yield to the author of the legislation Senator Frank Aguon to briefly speak on the bill. Senator Aguon.

Senator Aguon: Thank you very much Madam Chair and good morning Mr. Cameron. As you recall we had a round table discussion regarding the Hagåtña Restoration and apparently one of the suggestions was to look at including the Mayor of Hagåtña as part of the discussion by the Hagåtña Restoration Board so that in fact the Mayor whoever he or she is would have that opportunity to be able to contribute directly to that conversation. I want to thank Mr. Cameron, as well as some of the board members who endorsed that idea. What we have here is Bill 96 which would provide for the inclusion of the Hagåtña Mayor but it extends it a little further and perhaps this is where the conversation can come in. If you take a look at the Hagåtña Restoration Board and its statute and its mandates, it is very expensive in nature. It provides so much authority for the redevelopment of our capital city... rightfully so, and that's one of the reasons why I thought that perhaps we should consider having a legislative representative on the Restoration Board also to be part of that discussion and then ultimately to contribute in that fashion. So, this is inclusive of providing the Mayor of Hagåtña that opportunity to sit at the table, also a legislative representative to sit at the table as well so that in fact we can close the loop with overall representation. I ask you and our colleagues for your support. Thank you for having the hearing this morning... thank you Madam Chair.

Mr. Joseph Cameron: On behalf of the Hagåtña Restoration and Redevelopment Authority, we do clearly understand and thank you Senator Aguon for your kind comments. It was during the round table discussion, that Mada'am Chair, Senator Tina Muna Barnes, when you asked us to give you an update on what's going on. We are happy to say that we are going into phase III which is rezoning and implementation. We feel comfortable that we will actually come back to this august body before the end of the year, with a completed plan. But in doing so, we also knew that the formal engagement of the Mayor of Hagåtña was talked about and the Board recommended to this august body that we include the Mayor of Hagåtña. Likewise, I realize that this august body under the legislature of Guam has a sizeable amount of properties that it yields and manages and it would be to the benefit of the Hagåtña Restoration and Redevelopment Authority that as we move forward in finalizing any potential plans that would affect Hagåtña properties, a great sizeable amount is also owned by the Guam legislature. So, we do support this legislation. Thank you Madam Chair.

Senator Muna Barnes: Sai'na Ma'ase. Senator Respicio, I know you have a few comments.

Senator Respicio: Madam Speaker, I certainly support this legislation. Is the Speaker still here? Close your ears, Madam Speaker. I would like to ask, if there could be some discussion, because usually when a member from the legislature is appointed to serve in these capacities, it usually starts with the Oversight Chair. Because, on here it states that "one (1) member shall be appointed by the Speaker of the Guam Legislature, who shall serve at the pleasure of the Speaker", I'm wondering if it makes more sense if that member should be the person that has

Oversight of the Hagåtña Redevelopment Authority? The Chair really is driving these issues and jurisdictions and to have someone else serve in this capacity, does not sound right. I think it's something that we should talk about or maybe the author should talk to the Speaker about, which she does not yet, but will if this thing passes. I certainly support the bill and I hope we could consider having the oversight chair serve as a member in this capacity.

Mr. Joseph Cameron: I understand Senator, what you are trying to say, but I am not one to make that decision. Whatever decision is made, I will most certainly honor. Thank you!

Senator Muna Barnes: Sai'na Ma'ase. Madam Speaker, you have a few comments?

Speaker Won Pat: Thank you Madam Chair. You could tell the Majority Leader to close his ears as well. I just want to say that although whatever authority, at least with me as the Speaker, is that consideration is always given to the Oversight Chair to make an appointment. I've done that with GVB as well by asking the Chair and the Vice Chair and then the third will always be me by providing in-put as well. In this case as well, due consideration at least, is always given to the individual having Oversight Chair. That's not a problem with me as the Speaker, I can't speak for others, but that I can say. I wanted to ask a question of you? Primarily because in the last leadership meeting that we had with the Governor and the Governor, one of the topics brought up was difficulty finding individuals to serve on the Board because of all the legislative requirements. Your current 7 standing members, do they come on a regular basis? and the second question is, do you have any difficulty having a quorum?

Mr. Joseph Cameron: We meet regularly and we don't have problems with not having a quorum, but I am cognizant of the fact that there are many boards and commissions who may or may not that I am not very familiar personally. But with the Hagåtña Restoration and Redevelopment Authority, we have not had an issue with quorum. As a matter of fact we are looking at adding 2 additional memberships. It is a very interesting authority, it's just the mix and making sure that the authority has the necessary mix to move forward. It's just not one of those "adlibs" let's put somebody in. So, it makes a lot of sense that you have a concern, but on behalf of the board, they have been meeting regularly and we have had working sessions regularly, so we have not had a problem with having a quorum.

Speaker Won Pat: The other question that I have as well, considering the size and experience, is there any difficulty as far as making a decision-making, the larger the group, sometimes it's harder to get a consensus because of the increase from 7 to 9. How does that work now with the numbers increasing from 7 to 9, but what I was thinking that maybe keeping it at 5 but the 2 specific to the Mayor and the Legislative member...how does that work now?

Mr. Joseph Cameron: Well, I yield to your wisdom, Madam Speaker as to how you would like to move forward with that? But I will say that in each and every opportunity we have to meet, we always yield to all the members. We have been very fortunate in meeting. To answer your question, just keep it as is, out of the 7, those 2 memberships, I'll yield to your better judgement.

Speaker Won Pat: How much in stipend are the members receiving and do you have the funds to accommodate them?

Mr. Joseph Cameron: It's actually gratis!

Speaker Won Pat: I just want to make sure because there has been discussion as to the increase in membership and we want to make sure that you have the appropriate funds for it. Last question, on the last page of the legislation, it talks about non-voting ex-officio members, additional entities, DPW and GEPA, what are your thoughts?

Mr. Joseph Cameron: I haven't really had time to ponder on those two additional names that came in. I can probably imagine that the one from GEPA may deal specifically with environment and maybe DPW with flood zone issues. I can see the preponderance to collaborate with them. It doesn't stop us from communicating with them. It doesn't change the ability to meet or not having a quorum. There are several agencies that develop this authority to make sure that the plan is really met the litmus test that have to buy into that. It's really not problematic.

Speaker Won Pat: I just read something on page 2 about the Governor's appointment of a Commissioner. It says that "the Board may employ an Executive Director of the Authority who shall serve at the pleasure of the board, technical experts, such other officers, agents and employees, permanent or temporary as it may deem necessary". Has any of these happened? I'm sure an Executive Director has been appointed, but all the others?

Mr. Joseph Cameron: You are looking at the sole and lone ranger of the Hagåtña Restoration and it's also gratis! I am not a paid employee of the Hagåtña Restoration..everything is gratis!

Speaker Won Pat: Do you have the full compliment of all seven?

Mr. Joseph Cameron: No, not at all. We lack 2 more vacancies.

Senator Muna Barnes: You won't have a problem filling those vacancies, right?

Mr. Joseph Cameron: No, not a problem at all. Like I said earlier, this is a very big plan and it's important that we get the proper mix of people.

Senator Ben Pangelinan: Just a question on membership, do you have 5 total or 4, didn't someone just resigned?

Mr. Joseph Cameron: Yes, we have 7 total, but we had someone resign to another board, so we have 4 right now. We close to finalizing our list to send out to the Guam Legislature, soon.

Senator Frank Aguon, Jr.: Just a follow up question: thank you for forwarding that to the Guam Legislature. With respect to the inclusion of the two departments or agencies, GEPA and DPW, because Hagåtña has been recognized as being a flood zone, these two agencies will definitely be helpful with moving forward on the master plan. With regards to increasing the members to 9, I take into consideration that I didn't want to take away the appointing authority from the Chief Executive, but then again we could always be open to discussion. If it's the decision of the majority, I would be amenable to that. Thank you very much Mr. Cameron for being here to testify and thank you Madam Chair for allowing me to speak.

Senator Muna Barnes: Thank you very much, Senator Aguon. With that said, we call that Bill No. 96-32 (COR), publicly heard and adjourn at this time.

The Public Hearing was adjourned at **11:01 a.m.**

The eighth and ninth Commissioners shall be selected as follows: one of the Commissioners shall be the Mayor of Hagatna, who shall serve for the

2 of the Guam Legislature, who shall serve at the pleasure of the Speaker, and
3 whose appointment shall be effective until the conclusion of the term of the



AN ACT RELATIVE TO EXPANDING THE REPRESENTATION ON THE HAGATNA RESTORATION & REDEVELOPMENT AUTHORITY, TO INCLUDE THE MAYOR OF HAGATNA AND A LEGISLATIVE REPRESENTATIVE, AND FOR OTHER PURPOSES; THROUGH AMENDING §§79301 OF ARTICLE 3, CHAPTER 79, TITLE 21, GUAM CODE ANNOTATED.

BE IT ENACTED BY THE PEOPLE OF GUAM:

Section 1. §§79301 of Article 3, Chapter 79, Title 21, Guam Code Annotated, relative to the Establishment provisions of the Hagatna Restoration and Redevelopment Authority is hereby amended to read as follows:

“§ 79301. Establishment.

There is within, ~~and~~ a public corporation and autonomous instrumentality of, the government of Guam, the “HAGATÑA RESTORATION & REDEVELOPMENT AUTHORITY.” The powers, rights, privileges, functions and duties of the Authority shall be vested in ~~seven-(7)~~ nine (9) Commissioners, selected in accordance with the provisions in this Section. Seven (7) The Commissioners shall be appointed by the Governor, ~~by-and~~ with the advice and consent of the Guam Legislature, to serve for a term of five (5) years. The eighth and ninth Commissioners shall be selected as follows: one of the Commissioners shall be the Mayor of Hagatna, who shall serve for the

duration of his/her term(s); one (1) member shall be appointed by the Speaker of the Guam Legislature, who shall serve at the pleasure of the Speaker, and whose appointment shall be effective until the conclusion of the term of the Guam Legislature in which he/she was appointed.

(a) Before taking office or entering on duty, each Commissioner, as well as each employee of the Authority, shall take the oath of office required of all officers and employees of the government of Guam.

(b) Any Commissioner, **appointed by the Governor**, may be removed by the Governor for inefficiency, neglect of duty or misconduct in office, after a hearing before the Governor or a hearing officer specially designated by him for the purpose.

(c) A Commissioner shall receive no compensation for his services, but shall be entitled to payment of official travel costs and reimbursement of expenses actually and necessarily incurred in the discharge of his duties and functions.

(d) The Governor shall designate a Chairman and Vice-Chairman from among the Commissioners. The Commissioners shall constitute the Board of Commissioners of the Authority. The Board may employ an Executive Director of the Authority who shall serve at the pleasure of the Board, technical experts, such other officers, agents and employees, permanent and temporary, as it may deem necessary, and shall determine their qualifications, duties, tenure and compensation. For such legal service as it may require, the Authority may employ or retain its own counsel and legal staff. The Authority may delegate to one (1) or more of its officers, agents or employees, such powers and duties as it may deem proper. The Board shall adopt personnel rules pursuant to 4 GCA § 4105 and § 4106.

(e) **Four (4) Five (5)** Commissioners shall constitute a quorum of the Board of Commissioners of the Authority for the purpose of conducting the business of

1 the Authority and exercising its powers, and for all other purposes. A vote of the
2 majority of Commissioners present at any meeting of the Board shall prevail.

3 (f) Non-voting ex-officio members shall include representatives from the
4 Department of Parks and Recreation, the Richard F. Taitano Micronesian Area
5 Research Center, the Chamorro Language Commission, the Department of Land
6 Management, **Department of Public Works, Guam Environmental Protection**
7 **Agency**, and the Guam Preservation Trust. These members shall provide technical
8 assistance to insure accuracy in the development of the Plan.”

9 **Section 2. Effective Date.**

10 The provisions contained herein shall be effective immediately upon
11 enactment of this Act.
