

THE MAYORS COUNCIL OF GUAM.

BE IT ENACTED BY THE PEOPLE OF GUAM:

Section 1. § 13106 of Chapter 13 of Title 3, Guam Code Annotated, is amended to read:

“§ 13106. Events Causing Vacancy in the Municipal Offices of Mayor and Vice Mayor.

The municipal offices of Mayor and Vice Mayor become vacant on the happening of any of the following events:

- (a) death of the incumbent;
- (b) declaration of mental incompetence by a final judgment or final order of a court of competent jurisdiction;
- (c) resignation from office;
- (d) refusal or failure to assume office;
- (e) the decision of a competent tribunal declaring void his or her election;
- (f) conviction of a felony, or of a crime involving moral turpitude;
- (g) his or her change of residence from the municipality in which he or she was elected;
- (h) when an incumbent is incapacitated because of illness and unable to continue for the remainder of the term to which he or she was elected; or
- (i) when an incumbent has sought and won election to another office and assumed the new office, constituting *voluntary relinquishment* of the original office.

1 The occurrence of any event under (a) through (i), with respect to a
2 person or persons elected to office, after the election but before the term of
3 office is to commence, constitutes a vacancy on the date the term
4 commences, *unless* the person or persons so elected is the incumbent, in
5 which case, the vacancy occurs on the date of such event.”

6 **Section 2.** A new § 13107 is *added* to Chapter 13 of Title 3, Guam Code
7 Annotated, and the existing §§ 13107 and 13108 are renumbered accordingly:

8 “§ 13107. **Special Election to Fill a Vacancy or Vacancies in the**
9 **Municipal Offices of Mayors and Vice Mayors.** The Guam Election
10 Commission *shall* call for a special election on a Saturday on or about sixty
11 (60) days after a vacancy occurs in an office of Mayor or Vice Mayor,
12 whenever one (1) or more vacancies occur therein two hundred forty (240)
13 days or more *prior* to the date of the next general election for Mayors and
14 Vice Mayors. There shall be no primary election. Candidates must file their
15 candidacies *no later than* thirty (30) days prior to the special election date.
16 The highest vote-getter (or vote-getters if there is more than one [1]
17 vacancy) *shall* be certified by the Guam Election Commission as elected and
18 *shall* be administered the oath of office immediately to fill the unexpired
19 vacancy. If both Mayor and Vice Mayor offices are vacant, resulting in a
20 special election for two (2) vacancies, the highest vote-getter *shall* become
21 the Mayor-Elect, and the second highest *shall* become the Vice Mayor-
22 Elect.”

23 **Section 3.** §6105(b) of Chapter 6 of Title 3, Guam Code Annotated, is
24 *amended* to read:

25 “(b) *No* person *shall* be eligible for an office to be filled in an
26 election if sixty (60) days prior to the primary he or she is holding another
27 elective office, the term of which will *not* expire on or prior to the date of

1 commencement of the term of office for which he or she is running, with the
2 exception of any elective office for which a special election would be
3 required in the event of a vacancy.”

4 **Section 4.** § 40110 (a) and (b) are *amended*, and Subsection (c) is *deleted*,
5 of Chapter 40 of Title 5, Guam Code Annotated, to read:

6 **“§ 40110. Vacancies.**

7 (a) Vice-Mayors. A vacancy in the office of the Vice-Mayor
8 *less than* two hundred forty (240) days before the date of the next general
9 election for Mayors and Vice-Mayors *shall* be filled for the unexpired term
10 by a majority vote of the municipal planning council of the municipality in
11 which the vacancy occurs, subject to the advice and consent of *I Liheslatura*
12 (the Legislature).

13 (b) Mayors. *If* by reason of death, resignation, removal from
14 office, inability or failure to perform, there shall be a vacancy in the office of
15 the Mayor *less than* two hundred forty (240) days before the date of the next
16 general election for Mayors and Vice-Mayors, it *shall* be filled by the Vice-
17 Mayor in a municipality where there is a Vice-Mayor, and there *shall* be a
18 vacancy in the position of Vice-Mayor until the end of the term. In a
19 municipality where there is no Vice-Mayor and the vacancy is *less than* two
20 hundred forty (240) days before the date of the next general election for
21 Mayors and Vice-Mayors, the vacancy *shall* be filled by a majority vote of
22 the municipal planning council of the municipality in which the vacancy
23 occurs, subject to the advice and consent of *I Liheslatura* (the Legislature).”

24 **Section 5.** Section 8 of Chapter VIII of Public Law 32-068, Mayors
25 Council of Guam Lump Sum Payment Reimbursement, is *amended* to read:



Transmitted herewith is the Committee Report on Bill No. 241-31 (COR) – “An act to amend Title 3 GCA § 13106; to add a new Title 3 GCA § 13107; to renumber the existing §§ 13107-13109; to amend item (b) of Title 3 GCA § 6105; to amend items (a) and (b), and to delete item (c) of Title 5 GCA Chapter 40 § 40110; relative to a vacancy in a Mayor's or Vice Mayor's Office, and to provide for a Special Election to fill any vacancy among Guam Mayors of Vice Mayors, provided that such vacancy or vacancies occur 240 days or more before the date of the next General Election for Mayors and Vice Mayors” – sponsored by R.J. 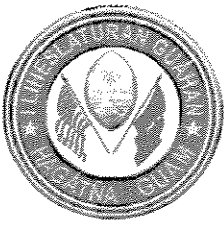

It was introduced by Senator Rory Respicio, Senator Tom Ada and myself, Senator Muña Barnes. We have the Executive Director of the Mayor's Council of Guam, Mr. Angel Sablan to speak on the bill, however I will yield now to the author of the bill, Senator Respicio to speak on the bill. Senator Respicio?

Senator Rory Respicio – Thank you Madam Chair and Acting Speaker for having this hearing. I want to thank you and Senator Tom Ada for co-sponsoring this bill. This bill seeks to amend the process of filling vacancies that may take place in the Mayor of Vice Mayors offices and to provide for a special election to fill any vacancy when they take place 240 days or more before the day of a general election. The current system as it is now, calls now for vacancies to be filled by the method of appointment by the Governor but the method of appointing rather than conducting a special election may not express the actual will of the people of that respective village. That's the primary way we elect our Mayors and Vice Mayors through the election process. So, what it is now, if this bill passes and should a vacancy occur within 240 days or 8 months of the next scheduled election, the vacancy will be filled by majority vote of the MPC of that municipality in which the vacancy occurs subject to the advice and consent of the Legislature. This method of filling vacancies less than 8 months before the next general election, empowers the MPC, which consists of those most familiar with the needs of their village. The other thing this bill does is provide for a Mayor or Vice Mayor to be eligible for an elected office in the same election inclusive of local and general elections. As it is now, the Mayors or Vice Mayors have to resign if they are going to seek another elected office because their term lapses. One can make an organic act argument that they do not have to resign, it's been much argued in the past and it seems that the determination is all subjective. While this bill primarily deals with elections, I contend that it's primarily an oversight I have with election reform I certainly have no problem yielding to you Acting Madam Speaker because it concerns Mayors and Vice Mayors and we need to hear from them and see what they want. All these amendments are made to the election code and I'm happy that the Executive Director of the Guam Election Commission, Ms. Maria Pangelinan, is here and maybe she may want to provide testimony. But nonetheless, thank you for moving the hearing and thank you for addressing a bill that recognizes how our Mayors and Vice Mayors have really grown from the time they were Commissioners and now they are Mayors and Vice Mayors. Thank you!

Chairperson – Thank you Mr. Majority Leader. I'd like to acknowledge Mr. Angel Sablan, Executive Director of the Mayor's Council.

Mr. Angel Sablan – Good morning and Mana Si Yu'os. My name is Angel Sablan, Executive Director of the Mayor's Council of Guam. Thank you and Merry Christmas to all of you! The proposal before us this morning is Bill No. 241-32 (COR) and the essence has been discussed back and forth with the different Mayors and Vice Mayors of the Council and we wondered if we had vacancies what would happen. We have some who are asking if they don't finish their term this year, what would happen to their villagers? We have some Mayors who are looking to other opportunities and we have Vice Mayors in their villages who don't want to step up but want to stay in their position. So, what's in the law right now is of course the MPC of that village would recommend a name to the Governor for appointment, but the Governor does not have to stick to that list nor accept nominees submitted by the MPC. We have one incident in the village of Agat, where the Vice Mayor was appointed by the Governor. I know the election commission is going to say that it's gonna cost more money, but I think it's the fairest way to fill that position. No one else would know but the villagers themselves. All in all, I think that this is a bill that deserves your consideration and support and it takes away the fact that it would have up to ten people deciding the Mayor Vice Mayor of that village, it should be the people of that village to decide. Thank you!

Chairperson – Thank you very much Mr. Sablan. Senator Respicio? Senator Lintiac? Any of my Colleagues? Senator Aguon, you're recognized.

Senator Frank Aguon – Thank you Mr. Sablan for providing testimony this morning. First and foremost, any time that you empower the members of the community in which the Mayors to be selected, you are empowering the entire village, so members of the MPC would be able to make their selection. The concept itself is very good. I'm looking at the existing process, I think you highlighted perhaps an aspect there that if in fact is tweaked slightly could still address a concern that you just shared with us and one is, names transmitted to the Chief Executive and the Chief Executive's concurrence eventually comes to the Legislature for confirmation. So if in fact the Chief Executive is somewhat, I don't want to say forced, but has to select a nominee or an appointee from that list, you still maintain the empowerment of the MPC because that Chief Executive would not have the flexibility to say, ok this is only advisory in nature, so I'm gonna step aside and provide that appointment. I certainly recognize the intent of the legislation of looking at the ways should a vacancy occur, what perhaps would be the most expeditious approach in terms of getting a replacement of a Mayor or Vice Mayor and empowering the MPC and eventually overall the concept is empowering that municipality or that village in allowing the villagers in selecting their Mayor or Vice Mayor. I just wanted to make that particular statement or comment because I think that you're absolutely right. I appreciate your

comment and I certainly understand the perspective of the sponsor to this legislation, so thank you for your comment.

Mr. Angel Sablan – Senator, I think that can still happen. In periods of time where there is 40 days or less because there is no election, there has to be a process where you're going to have to appoint a Mayor or Vice Mayor, so I think that process can still work.

Senator Frank Aguon, Jr. – Thank you Madam Chair.

Chairperson – Thank you Senator Aguon. I just want to note that there are 19 Mayors and 7 Vice Mayors and for the villages that have the Vice Mayor positions, they automatically move up but the villages that don't have that position then this would be put into play.

Mr. Angel Sablan – Yes, but what I was pointing out Senator is that if the Vice Mayor doesn't want to step up to become the Mayor, and it's right here, it's refusal or failure to assume office, so it's still covered. So the Vice Mayor would still have to declare or assume the position of Mayor.

Chairperson – Ok, that's correct. Thank you Mr. Sablan. Do any of my other colleagues like to make a comment? Senator Respicio you're recognized.

Senator Rory Respicio – Thank you Madam Chair, and happy holidays Mr. Sablan. Before this committee submits the committee report for this bill, could the Mayor's Council have a resolution submitted to us?

Mr. Angel Sablan – Yes, of course, we have a meeting on January 8, 2014. We are working on 2 resolutions and this is one of them.

Senator Rory Respicio - It would be helpful to us if the Council could take a vote on it and we could be guided by it. Thank you Mr. Sablan.

Chairperson -- Thank you very much. If there are no other comments, I will call this bill duly heard and adjourned at 9:29 a.m.

"AN ACT TO AMEND TITLE 3 GCA § 13106; TO ADD A NEW TITLE 3 GCA § 13107; TO RENUMBER THE EXISTING §§ 13107-13109; TO AMEND ITEM (b) OF TITLE 3 GCA § 6105; TO AMEND ITEMS (a) AND (b), AND TO DELETE ITEM (c) OF TITLE 5 GCA CHAPTER 40 § 40110; RELATIVE TO A VACANCY IN A MAYOR'S OR VICE MAYOR'S OFFICE, AND TO PROVIDE FOR A SPECIAL ELECTION TO FILL ANY VACANCY AMONG GUAM MAYORS OR VICE MAYORS, PROVIDED THAT SUCH VACANCY OR VACANCIES OCCUR 240 DAYS OR MORE BEFORE THE DATE OF THE NEXT GENERAL ELECTION FOR MAYORS AND VICE MAYORS."

Bill No. 241-32 (COR) is a simple piece of legislation that seeks to amend the process of filling vacancies that may take place in a Mayor's or Vice Mayor's office, and to provide for a special election to fill any vacancy when they take place 240 days or more, before the date of the next general election for Mayors and Vice Mayors.

The current system calls for appointments to fill vacancies to be made by *I Maga'Lahi*, but the method of appointing rather than conducting special elections, may not express the actual will of the people of the village that the Mayor or Vice Mayor serves. That is primary reason that we conduct elections for Mayors and Vice Mayors in the first place.

Should vacancies occur within 240 days (8 months) of the next scheduled election, the vacancy will be filled by a majority vote of the Municipal Planning Council of the municipality in which the vacancy occurs, subject to the advice and consent of *Lihestatura*. This method of filling vacancies less than 8 months before the next general election, empowers the MPC, which consists of those most familiar with the needs of their village.

Bill 241-32 also takes into account the possibility of vacancies in both offices, and requires that any candidate can be eligible for only one elective office in the same election, inclusive of local and general elections.

According to information received from the Executive Director of the Guam Election Commission, this would apply to a vacancy of 240 days or more prior to the date of the next general election which would be applicable to a vacancy occurring before or by March of 2016. Next, the Executive Director continued to explain that the cost impact would vary depending on the village the vacancy occurred. For example, if a Mayoral vacancy occurred in the village of Agana Heights, there is only 2 precincts. Thus, the cost involved would be less compared to the village of Dededo that has 13 precincts. The fiscal impact would result primarily from the number of ballots required to be printed, supplies and staff required to conduct the Special Election. Finally, it was mentioned that for this Special Election, the ballot counting equipment will not be used. Instead, all ballots will be hand counted. This could minimize the overall cost impact.

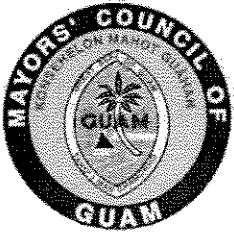

At its regularly scheduled monthly meeting yesterday, the Mayors' Council of Guam unanimously supported a motion made by Piti Mayor Vicente Gumataotao and seconded by Chalan Pago- Ordot Mayor Jessy Gogue to support the passage of Bill 241-32, AN ACT TO AMEND TITLE 3, SECTION 13106: TO ADD A NEW TITLE 3 GCA SECTION 13107; TO RENUMBER THE EXISTING SECTIONS 13107 – 13109; TO AMEND ITEM (B) OF TITLE 3 GCA SECTION 6105; TO AMEND ITEMS (A) AND (B), AND TO DELETE ITEM (C) OF TITLE 5 GCA CHAPTER 40 SECTION 40110; RELATIVE TO A VACANCY IN A MAYOR'S OR VICE MAYOR'S OFFICE, AND TO PROVIDE FOR A SPECIAL ELECTION TO FILL ANY VACANCY AMONG GUAM MAYORS AND VICE MAYORS PROVIDED THAT SUCH VACANCY OR VACANCIES OCCUR 240 DAYS OR MORE BEFORE THE DATE OF THE NEXT GENERAL ELECTION FOR MAYORS AND VICE MAYORS. This bill was introduced by Senator Rory Respicio of *I Mina Trentai Dos Na Liheslaturan Guahan*.

The proposed legislation allows Mayors and Vice Mayors to seek other elective offices within their prescribed terms of office without having to resign from office. It also allows those villages with Vice Mayors to have an incumbent Vice Mayor make the personal decision to assume the office of Mayor or not if there is vacancy in the mayoral position. It further allows for a special election to be set if a vacancy for Mayor or Vice mayor occurs 240 days or more before the date of the next General Election for Mayors and Vice Mayors.

Footnotes:
According to information received from the Executive Director of the Guam Election Commission, this would apply to a vacancy of 240 days or more prior to the date of the next general election which would be applicable to a vacancy occurring before or by March of 2016. Next, the Executive Director continued to explain that the cost impact would vary depending on the village the vacancy occurred. For example, if a Mayoral vacancy occurred in the village of Agana Heights, there is only 2 precincts. Thus, the cost involved would be less compared to the village of Dededo that has 13 precincts. The fiscal impact would result primarily from the number of ballots required to be printed, supplies and staff required to conduct the Special Election. Finally, it was mentioned that for this Special Election, the ballot counting equipment will not be used. Instead, all ballots will be hand counted. This could minimize the overall cost impact.

2 Section 1. "TITLE 3 GCA § 13106. Events Causing Vacancy in the
