





Comment on Bill No. 311-32(COR)

This proposed legislation seeks to make appropriations from any or all funds in Fiscal Year 2013 – 2014 from the Limited Gaming Fund in accordance with Public Law 32-060 to the Mayors Council of Guam, Department of Parks and Recreation and Guam Department of Education for the repair and construction of its sports or recreational facilities.

P.L. 32-060 authorizes that monies remaining in the Fund, after maintaining the stated reserves for administrative expenses, shall be appropriated up to one third (1/3) of the available balance to the Mayors Council of Guam (MCOG), up to one third (1/3) of the available balance to the Department of Parks and Recreation (DPR) and up to one third (1/3) of the available balance to the Department of Education (DOE). Based on information from Department of Administration, the fund balance of the Limited Gaming Fund as of 3/31/14 is \$989,381.60. As such, the MCOG, DPR and GDOE shall receive an appropriation in the amount of \$313,303 each as outlined below.






