



AN ACT TO REPROGRAM THE SUM OF THREE HUNDRED SEVENTY FIVE THOUSAND DOLLARS (\$375,000) TO THE DEPARTMENT OF PUBLIC WORKS FOR THE PAVING OF VILLAGE STREETS, AND THE REPAIR OF DAMAGES TO VILLAGE STREETS AS A RESULT OF TRAFFIC DIVERSION RELATED TO ONGOING ROAD CONSTRUCTION PROJECTS.

BE IT ENACTED BY THE PEOPLE OF GUAM:

- 2 Section 1. Appropriation to the Department of Public Works for
- 3 Various Road Repairs. The sum of Three Hundred Seventy Five Thousand
- 4 Dollars (\$375,000) is hereby appropriated from the balance of the appropriations

contained in § 1513 of Article 5, Chapter 1 of Title 5, Guam Code Annotated, to the Department of Public Works for said purposes.

- **Section 2.** Additional Authorizations. Of the amounts appropriated in Section 1 of this Act, *not less than*:
 - (a) Three Hundred Forty Five Thousand Dollars (\$345,000) is reserved for Roy T. Damian Street, aka Route 33 in *Mongmong/Toto/Maite*, for the spot repair of street damage caused by heavy travelers' use to bypass the major road construction in *Hagatña*. The Director of Public Works may authorize *no more than* Forty Thousand Dollars (\$40,000) to resolve safety issues, such as the application of anti-skid pavement on portions of public side roads that are immediately abutting Roy T. Damian St.
 - (b) Thirty Thousand Dollars (\$30,000) is reserved for Mamis Street in *Mangilao* for the paving of a portion of a second lane to be installed.
 - (c) The funds identified herein *shall* be applied *solely* for the purposes set forth.
- **Section 3.** The Director of the Department of Public Works, the Department of Public Works Highway Maintenance and Construction Division, and the General Manager of the Guam Power Authority *shall* ensure that all applicable laws are appropriately complied with which legally address any and all easement and/or encroachment matters of all abutting landowners affected *prior* to the expenditure of any appropriations authorized in Section 2 of this Act.
