### I. COMMITTEE PROCEEDINGS

Note: Chairman Crnz had to step away from the public hearing temporarily to attending another meeting. Senator Frank Aguon, Jr. was asked to convene the meeting in his absence.

Senator Frank Aguon, Jr. We're going to proceed to Bill No. 348. Mayor, I understand you are going remain there at the table as well as Mr. Borja. Bill No. 348 is an act to rezone Lot No. P10.9A-3-16, in the Municipality of Dededo from Agriculture to Commercial. We have Mr. Borja and Mayor Savares signed up to provide testimony. If anyone else in the audience here would like to provide testimony, I ask you to please proceed to the table. If not, Mayor?

Mayor Melissa Savares. Thank you for the opportunity. My name is Melissa Savares, Mayor of Dededo. We do have a resolution, a Municipal Planning Council Resolution of support that I provided to the staff to support the rezoning from agriculture to commercial for these two lots. We did restrict it to...there are five housing units within the immediate area of this properties. We have the Sagan Ypaopao area, Ypaopao Estates, Woodland Town Homes, Benson Subdivision, and now Paradise Estates that are located within the immediate vicinity of these two properties; off Chalan Langet. We have a DPW report that was presented at the Municipal Planning Council meeting that does show the roadway will be adequate to the zone change as well as the regulating agencies from GWA, EPA, and GPA.

**Senator Frank Aguon, Jr.** Thank you very much, Mayor for your testimony for this proposal. Mr. Borja?

Mr. Michael Borja. Like the previous three bills, for Bills 347 and 348, again we -- you know the process is in one of them. There's already a conditional land use (permit) on one of those properties. They were allowed to build a convenience store and the store is there. Now, they're changing it to commercial. In light of Mayor Savares's Municipal Planning Council Resolution supporting the change to commercial zoning - that would have been our most overwhelming concern. But likewise, we need to understand some of the concerns of the other regulatory agencies, to include EPA and others. In light of this, we're not going to stand in the way of one's desires to improve their livelihood and their business for this property, but we would still prefer to have them go through the channels. We would like to get a copy, for the record, from the Municipal Planning Council and we'll be in touch with Mayor Savares's office for the Municipal Planning Council resolutions.

**Senator Frank Aguon, Jr.** Thank you very much, Mr. Borja for your testimony this morning on this proposed measure.



Buenas yan Hafa Adai! The Department of Land Management has reviewed each of the listed bills and submits the following:

Each of these bills calls for the rezoning of a lot that is either Agricultural or Residential to Commercial. This legislation is asking properties to be rezoned without the vetting necessary in our Territory's statues that calls for the "technical and professional review, analysis, advice, and agency positions concerning various development activities on Guam."

The Application Review Committee (ARC) made up of our regulatory agencies is mandated to review requests for zone changes that are submitted to the Department of Land Management. Their tasking is:

- (a) Ensure compliance with regulatory standards, procedures, policies, rules and regulations;
- (b) Ascertain the overall environmental, socioeconomic, infrastructural and cultural impact of proposed projects;
- (c) Evaluate alternative development activities or subdevelopment alternatives with applicant/developer/petitioner to provide the best development plan for the community;

- (d) Assist other ARC member agencies and other government agencies in establishing social, physical infrastructural, economic, and cultural programs and standards for the proper development of Guam's present and future growth;
- (e) Develop and provide official position statements by government of Guam agencies on applications submitted under the Zoning and Subdivision Laws, the Territorial Seashore Protection Act and other such laws as may be enacted by the Legislature.

By curtailing this review process, lots may be rezoned that may not be in compliance with regulatory standards. Additionally, the broad nature of a commercial zone may be contrary to the desires of the immediate surrounding communities since there is no input from the respective municipal planning councils.

The Department of Land Management greatly supports zone changes especially when they are in the economic interest of our island and to the benefit of the land owner. We encourage business development and strongly recommend using the processes already in place so we can ensure that the tools necessary for business development are available to land owners who seek to change the zoning of their property. In most of these bills, the need for a commercial zone may meet the needs for the area but without the agency reviews there is no way beforehand to determine if the regulatory requirements are satisfied. Subsequently, when building permits or business licenses are later sought, there may be restrictions that complicate their issuance. In most cases, rezoning is permitted in the normal application process but identified issues are noted and conditions on the rezoning are placed to ensure the matter is recorded for all future use.

#### AN ACT TO REZONE LOT NO. P10.9A-3-16, IN THE MUNICIPALITY OF DEDEDO FROM AGRICULTURE (A) TO COMMERCIAL (C).

#### BE IT ENACTED BY THE PEOPLE OF GUAM:

Notwithstanding any other provision of law, the following lots are as described below are hereby rezoned from Agriculture (A) to Commercial (C.):

> Lot No. P10.9A-3-16 in the municipality of Dededo, containing 2,039 square meters or feet, referenced to map filed under Document No. 108FY92, C.T. Number 00000470111

**Section 2. Effective Date** This provision contained herein shall take effect immediately upon enactment of this Act.

**Section 3. Severability** If any provision of this Act or its application to any person or circumstance is held invalid, the invalidity shall not affect other provisions or applications of this Act which can be given effect without the invalid provision or application and to this and to this end the provisions of this Act is severable.
