

I. COMMITTEE PROCEEDINGS

Chairman Benjamin Cruz: We have one more bill to be heard: that is Bill 354. The sponsor is Senator San Nicolas and I will give him the opportunity to make an opening statement or sponsor statement.

Sponsor Statement

Senator Michael San Nicolas: Thank you again Mr. Chairman. Thank you for having this bill heard as quickly and timely as you have. I know that you are working a large back log and your efficiency is very impressive. Just in a nutshell, this bill intends to clarify the existing zoning laws and residential, commercial, and industrial properties with respect to political signage. The existing law makes a lot of the current signs that are on private properties technically illegal based on Guam standards. The assumption is that it's a free speech issue and if it ever gets challenged in court, it's not going to hold up. So that law should be changed. But for me so long as we have the books contrary to what the practice and the interpretation and the belief is, then we need to make the law consistent.

This was initially brought up by former Senator Robert Klitzkie months ago and it's kind of getting around to being addressed now with the political signs coming up and a lot of them violating this particular provision in the zoning code. So what this bill would do is it will allow private property owners to have an exemption with respect to the signage they place in their properties as they relate to political parties, political causes, their political candidates. This is just a, I would say, very clean and collegial way for us to address this issue without having to point anybody out or anything. I think the free speech argument does hold up. We can't restrict people from being able to express who they are supporting and demonstrating how they are going about doing that. This bill will allow our zoning laws to be consistent with our constitutional rights, I would say. And for the political signage that is currently up to remain up without this contradiction in law existing. Thank you Mr. Chairman for this opportunity to move this bill forward and I'm hoping we can get this passed quickly because it is election season. Thank you Mr. Chair.

Chairman Benjamin Cruz: Thank you. We do have one person willing to testify. Okay, just...quick testimony – that's great.

Mr. Bill Cundiff: To clarify this particular issue in the community, the freedom of speech is the political right to communicate one's opinions and ideas using one's body and property to anyone who is willing to receive them. The term freedom of expression is sometimes used synonymously but includes the act of seeking, receiving, and importing information or ideas regardless of the medium used. I think we should be very careful on how we tell people what to do on their private property. There are laws - there's a law in Alaska—basically, I read the Alaska laws. Something similar to this but it has the same idea to ensure we don't infringe on the free speech of people. So, I 100% support this bill. I just...there's only one clarification is that the new Item 3 is hereby added to 5651615c and everything, is there a way you can put private property in there somewhere?

Senator San Nicolas: To clarify the question, Mr. Chair if I may. These are all the various sections that are governing the private properties. Section 2 is a specific section in the law that addresses residential and agricultural. In Section 3 there's already an existing specific section in the law that addresses commercial. In Section 4, there's already a specific section in the law that addresses industrial. Each of those individual

sections change parts in the law to exempt these political signs and the clauses, so they already touch on the existing statutes that addresses the private properties.

Mr. Bill Cundiff: Alright, thank you.

Chairman Benjamin Cruz: Thank you very much Mr. Cundiff. The committee has completed this afternoon's agenda: Bill 354 is considered heard.

This concludes the testimony on Bill No. 354-32 (COR). There being no additional individuals to present any additional testimony, this Committee will continue to remain open for the acceptance of any additional information or public testimony on the bill discussed. BUREAU OF BUDGET AND MANAGEMENT RESEARCH COMMENTS ON BILL NO. 354-32 (COR)

The proposed legislation is aimed at *amending* Section 3, Section 4, and *repealing* Section 6, of Public Law 21-130, to authorize the Department of Land Management to exchange private property taken for the construction of the Agat-Umatac Highway with the Government of Guam.

Should this proposed legislation become law, the 21 lots of Block 5B, Tract 3241 will be distributed to the private owners of properties utilized in the reconstruction of the Agat-Umatac Highway. The private owners include the following: Louise G. Sanchez, Herbert R. Gofigan, Victoria G. Sanchez and Gregorio Q. Gofigan, Sylvia G. Quinata, and Vicente A. Quinata. The intent of the proposed legislation is to properly compensate the above stated private property owners after the original enactment of P.L. 21-130 to reconstruct the Agat-Umatac Highway over twenty-one years ago.

The exchange of the 21 lots of Block 5B, Tract 3241 for the properties owned by the above stated private owners will be conducted on a value for value basis. Due to the exchange being conducted on a value for value basis, there should be no increase or decrease to land inventory owned by the Government of Guam.

The proposed legislation stipulates that the government lands designated for exchange are based on recorded and registered maps with the Department of Land Management. However, there is no component of the proposed legislation that waives the fee to register the subject government properties after it is exchanged with the above stated private property owners. The fee to register a parcel of property amounts to \$25.00 per parcel of land and \$40.00 for the first issuance of Certificate of Title in a Land Registration Case. This amounts to approximately \$65.00 per parcel of land, which 21 lots are designated to be exchanged through this proposed legislation. Based on the above stated costs, the Bureau estimates that \$1,365 will be received by the Department of Land Management in the form of Land Registration and Filing fees.

If the proposed legislation is passed, the subject properties currently owned by the Government of Guam will be exchanged on value-for-value basis with the private property owners whose lands were used in the reconstruction of the Agat-Umatac Highway. There is a potential of revenues received by the Department of Land Management in the form of Land Registration and filing fees.
