



3 a happy community and our work to maintain a viable tourism economy often  
4 seems worlds apart. Dumping, litter, graffiti, loss of language, and a watering  
5 down of culture – these issues pose difficult challenges in the tourism industry, but  
6 are also indications that our own community is in need of mending. A healthy  
7 community takes better care of their island, making it more appealing to tourists.

8           *I Liheslaturan Guåhan* further finds that in 2012, Duk Duk Goose, Inc.  
9 produced three sample/pilot episodes of a children’s program, entitled *Nihi*, which  
10 beckons viewers to new adventures of learning fun. In January 2013, Duk Duk  
11 Goose, Inc. held a private viewing for a test group of parents and children. The  
12 production of these sample episodes were partially funded by the Guam  
13 Preservation Trust and the Council for the Arts and Humanities Agency (CAHA),  
14 with the remaining cost covered by in-kind donations of skill, time, and other  
15 donated resources.

16           *I Liheslaturan Guåhan* further finds that as a government, we must do our  
17 part in an effort to preserve and protect our unique language, culture, stories,  
18 identity, and resources; instill a confidence and pride in our unique identity and our  
19 island community; inspire a deep love for our water, land, and people; and promote  
20 sustainable and healthy ways of living.

21           *I Liheslaturan Guåhan* further finds that this cultural children’s television  
22 program would have immediate benefits to the tourism industry, such as a  
23 YouTube channel for children that potential tourists and their children could watch  
24 and follow, becoming familiar with Guam and intrigued by our language, custom  
25 and culture which would showcase Guam as a family-friendly destination. For  
26 visitors, this children’s programming could be made available on the visitor’s

1 channel, in airport and hotel lobbies, and in hotel rooms, where visitors could listen  
2 to our unique language, and see some of the unique and important places on Guam.

4 to every elementary public school child having access to this programming. The  
5 benefits to tourism would be unquestionable and the benefits for our community  
6 would be immeasurable.

7 *I Liheslaturan Guåhan* further finds that revenue estimates for the Tourist  
8 Attraction Fund (TAF) for Fiscal Year 2013 are tracking at Twenty-six Million  
9 Five Hundred Seven Thousand Three Hundred Twenty-nine Dollars  
10 (\$26,507,329), of which Twenty-three Million Eight Hundred Eighty-eight  
11 Thousand Two Hundred Dollars (\$23,888,200) is appropriated.

12 *I Liheslaturan Guåhan* further finds that the TAF revenues for Fiscal Year  
13 2013 are projected to exceed appropriations by One Million Seven Hundred Eight  
14 Thousand Four Hundred Eighty-eight Dollars (\$1,708,488), in addition to the





**Cara Flores-Mays:** Dr. Bevarqua needs to leave so I'd like him to start.

**Michael Bevarqua:** Hello and hafa adai. My name is Michael Bevarqua I'm a Professor at the University in charge of the Chamorro Studies there. And Chamorro Studies is a sponsor for this production for the Nihi kids show. I also helped write it and so... this is my daughter Sumahi. My testimony is in Chamorro I'm going to read it. Este haga'hu I na'ana si Sumahi. Desde ma'fanagu gue hu fumino Chamorro'yi gue todo I tiempo. Humuyung'na sina gue fumino Chamorro esta maas gue fino Chamorro. Kada diha kumentos ham put movies, siha cartoons, yan lebblu maseha hafa na otro li'nalan mami. Gi iya hami na dos, hu fana'nague gai bali este I lenguahi'ta fino Chamorro esta ha kumpre'prende na impottantte este para hami. Lao I otro na ileksion ti umayak yan este. **Senator Muna Barnes:** Buen probetchu Sinot Bevarqua. Excuse me Dr. Bevarqua, the Vice Speaker has a question.

**Vice Speaker:** Before Dr Bevaraqua leaves, I feel that the community needs to understand that a couple of weeks ago I had one of my proudest moments as chairman of Pa'a, I was at the Guam Symphony when they did Ode to Joy and I was so proud to hear the Ode to Joy written by Beethoven sung in Chamorro and it was beautiful. I'm sorry you weren't there but it was beautiful and I just wanted the community to understand that and if for some reason the Guam Symphony and the Guam Chorale does that performance again, I would really encourage the entire community to turn out and listen to it because you would be very proud of our language and the way that he translated it from German to English and then from English to Chamorro and the way it was sung was just as beautiful. Thank you.

**Senator Muna Barnes:** Thank you so very much... Miss Cara.

**Cara Flores-Mays:** I'm Cara Flores-Mays, and to introduce our program, I'd like to show you the trailer (shows "Nihi" Video). So I just wanted to thank all of you, I know that it's been a long day so we'll try to keep it brief. So we'll go ahead and let others speak and then Mary and I will finish up.

**Senator Muna Barnes:** Thank you Miss Mays.

**Bernie Grajek:** Thank you and good afternoon, my name is Bernie Grajek I'm here as a private citizen and a person that is part of this demographic that Dr. Underwood spoke of earlier. I am over 50 and so I grew up in a home where my father is Philipino and my mother is very, very Chamorro but because of the 2 different cultures in the home and 2 different languages, English was going to be the common language, so we spoke English. But I had a nana, my grandmother who absolutely refused to speak English so I did learn Chamorro and I could understand everything that was said today but as with some of you having what they say in Chamorro "apling"... and when I find myself... I work at the Sinajana Community Center with Guma Mami, and so I'm right I'm right next door to the Sr. Center. So when I'm with the man amkos, it's very easy for me to speak Chamorro, it just comes out... it just happens, it just bursts out. All of these programs (Inetnon, Hurao and Nihi) are extremely important for our community. I appreciate the vice speaker's comment on corporate sponsorship. It is our responsibility as a community to teach our children our culture. My daughter is involved with Nihi as an illustrator. She is learning Chamorro through her friends and a dictionary like the one that Senator Tom Ada mentioned. After listening to everything today, there is absolutely no way that anyone of you would not support this fund. The TAF has gone to many different programs for many different things. The surveys tell us that the tourist are asking for cultural stuff and I think it would be cool for the tourist to turn on the TV and see "Nihi" on TV. I look at all of you here... when you go into session I know you would fund this program. Thank you so much, I know that a lot of the Senators were here earlier and I really appreciate that.

**Senator Muna Barnes:** You're very welcome Ms. Bernie... Mary Theresa.

**Mary Theresa Edgerle:** Madam Chair I was really compelled to come here when I saw the video to support this program. I have been here for a while and my husband just loved this island. I was born in Ireland and moved here with my family and my husband absolutely embraced this island and so did my son. So I had no choice but to stay. Now I call it home. I have been with mental health running a program assisting children with a mental disability. I was at a children's mental health conference in Portland, Oregon 10 years ago. We were there to learn about wraparound and how to provide services for children with serious mental health issues. I have not forgotten the panel of teens who presented there. Yes they were troubled children extremely naughty ones, who had been stealing, abusing drugs, high school dropouts and homeless. All of them had mental health needs and were receiving multiple services. They were all asked what do you think helped you the most? They talked about their need to belong. All of them said really getting in touch with their culture gave them a place that they felt they belonged... learning the old ways, singing and dancing that was something that was missing. They were now able to feel proud of their culture and that pride gave them a strong sense of

self and self-esteem. I believe Nihi has the potential to give the little ones that holistic connection early on in life, which may help prevent our island's children from feeling disconnected. Thank you for having me here.

**Senator Muna Barnes:** Thank you Mary Theresa.

**Bernie Grajek:** I just wanted to add one thing on what she spoke about and most of you are familiar with I Famagu'on'ta and karino and one of the things that the feds ask is what is needed is the component such as children's programs that address culture... cultural and linguistic competence. That is something that we've always been lacking. When they've come and done the reviews for those programs, they always ask where is your culture linguistic components of these programs. It's not like we don't have it... we have Inetnon, we have Hurao. We just haven't really seemed to be able to connect those things for kids outside of this. So the funding you provide will hopefully be able to reach the kids outside of the schools.

**Mary Theresa Edgerle:** I actually learned the Chamorro culture from a Japanese man than from a Chamorro. You know what he taught me? He took me to some sacred sites and he explained that this culture was 4,000 years old and the tourist are here to look and learn about the Chamorro culture so if you look at this, this is something amazing! So people who come here to visit need to be exposed to this. So I've come here to tell you that it's so important. Thank you.

**Senator Muna Barnes:** Thank you Mary Theresa for your comments here today. Also wanting to speak here this afternoon is Miss Marie... also there is Robert Anthony and Julie Namm and Dr. Evelyn Flores.

**Marie Ada Anyung:** Hafa Adai. My name is Marie Ada Anyung. I hope you don't mind if I concede I know there are others who wish to speak... if that's okay with you.

**Julie Namm:** Hello, my name is Julie Namm and I'm currently working at the Seventh Day Adventist Wellness Clinic as a family physician and I was invited to just share about the health aspects of the program that I think will be beneficial to the children of the island. I see patients day-in and day-out of all ages and so I see the new-borns all the way up to the elderly and I take care of patients at GMH as well. So, I think that the health component of this program will be very beneficial for the young children. They usually come to see me only once a year after they're walking and talking... it's a once a year child wellness visit and not even all the families in Guam bring in their children every year. It's simple things like eating healthy... like eating your fruits and vegetables, avoiding sugary foods, avoiding junk food, fast food, fried foods, exercising, getting enough rest, safety issues. These are just things that we are suppose to tell the patients every year as they come in for their wellness check. Once a year isn't enough to

drive the point home with these kids and the parents and something like this program will have children watching in their homes and their parents also watching and you can repeat it again and again and it can actually last for many years with the same program will be very beneficial for these kids. I just wanted to advocate for the program and I love the Guam culture, I've been here for 3 years and the people have been amazing especially the elderly patients... they're like my favorite ones, they come in and they'll bring me mangos from their tree, bring me avocados and they're even having a hard time paying for their medication but they're just so generous, so appreciative. I love the culture, I think the culture is a very generous culture, very family oriented which is not what I grew up with in the states and I get vey touched when I see people fundraising for their families for medical care, going to all these family gatherings even though they're tired and stressed from work, they'll still show up for their families and they get together quite often to celebrate... I guess each other and their family ties. I just want the health of the Chamorro people and the people of Guam to be better. I'm glad that this program had a component of health in each episode.

**Senator Muna Barnes:** Thank you Dr. Namm.

**Evelyn Flores:** My name is Evelyn Flores, I'm a Professor at the University of Guam, Professor of Literature, my specialty is pacific island literature and the goal of my research is the preservation of literature from our region. And some people don't even know that there is literature from our region so I'm trying to get that word out and my current project Mirconesia enthology which is at the press for review now which gathers writings from across this region. My next project will be a Chamorro literature, text book so we can begin having Chamorro literature at the University of Guam. I'm also a Professor, one of the core faculty in the Chamorro Studies Program at the University. When something needs attention in society the people respond in two ways, to complain about it and do nothing and then complain about it and then try to do something. I think this project is about trying to give attention in 3 areas of our society the first area is the health of our people, the physical health. We know from the statistics that we have huge problems with heart, diabetes, high blood pressure and these are all diseases that are life style related and even certain forms of cancer. The question is how do we get the word out to our people? The second area that is needing attention in our society is our language, and you know as well as I do that with my generation 1898 with a sweeping attempt to Americanize Guam that really sped up after WWII to erase the language that has been too successful and my generation is probably the first generation that is not even among us not even able to speak the language, we understand it but we do not speak it. And if can not speak it to our children as Miget pointed out, then our children can't speak it to their children and so a language is lost that way. I mean it's such a simple equation that's the way a language is lost. The third area that I want to talk about that needs attention in our society is our cultural values. I teach at the University of Guam and what disturbs me is that our students see it as... see being

Chamorro as kind of something that is not really relevant in today's society... it's more relevant to be as Americanize as possible, as modern as possible and the values that we have are values that they try to dismiss or avoid or denigrate... this means that they're denigrating their own value because we are Chamorro, those of us who are Chamorro whether we claim it or not so when we denigrate or dismiss our values, we denigrate and dismiss ourselves. So that is a disturbing thing that I see among our students. This project aims to address those areas by using the most powerful way to educate. Using the most powerful educator today is the media and not just television but computers... every kid goes on the computer and as a previous speaker said, computers can go around the world. And so you're marketing this and not just to Guam but across the world without having to go through PBD or any other organization like that. So this project aims to use one of the most powerful ways to educate and that's really important to get the idea out to the group that it needs to get out to which is our children. As we try to get the attention out to health, the language and values, get that turned around, how do we do that through the media? And should the tourist fund be used, that's a big question that you'll be debating... why use the tourist fund because this is an investment for the future tourism that has been pointed out. Tourist come to a place for its uniqueness not because its like what they have at home... and what is unique about Guam, what do we have that no one has? We have our culture... no one else has our culture. If we showcase our culture, perform it everyday... that's real important. That is why I think that it is a valid way to spend tourism funds. Thank you.

**Vice Speaker:** The Chair stepped out so I'm taking over. I want to thank you very much Dr. Flores for presenting. Marie did you want to speak... there's one other speaker.

**Robert Addy:** Hello my name is Robert Addy and I'm here to present testimony through a song from the children show and then my personal testimony and my support of it. **(Sings song)** That's a song that will be taught on the show. There are 2 points that I want to bring up about the show... the language component and the culture component. I'd start by saying Buenas yan hafa adai, guahu si Robert Addy, and that's how far I get in speaking Chamorro which is unfortunate. I don't need to tell the legislature that our language needs to be taught more... you all know that. The language is important for identity for the younger individuals and individuals with an identity are individuals that are better for the community. When I first heard about the show, a couple questions came to mind. One, why use the Tourist Attraction Fund to fund a show for our communities language and culture, and I think if we can help individuals through that identity of culture it would create a better community... a better Guam. What would we be like if the people forgot their culture, their family, of respect, of welcoming newcomers, and taking care of our island. I think this children's show Nihi intends to spread those values to all people. That's all I have to say... thank you.

**Senator Muna Barnes:** You're very welcome.

**Marie Ada Anyung:** Madam Chairman and honorable Senators, buenas yan hafa adai. My name is Marie Ada Anyung and I'm blessed to be a resident of Guam for the past 5 years. In the 5 years that I've been living on Guam, I've been involved in community work all this time. One of the first projects I actually worked on was at the Department of Youth Affairs. I was working on a film "Youth Inside" with 10 youth that were in the juvenile justice system. We did 2 productions, one was a documentary and the other was a theatrical feature. My background is in social services, I've done community-base education from HIV prevention to substance abuse prevention... right now I'm at the University of Guam with the new farmer program, we're trying to do market development as a liaison and the farmer's coop and the hospitality industry. Today I'm really struck by all the testimony that I've heard this afternoon for all the projects. It's my privilege to endorse the appropriation from the TAF funds for the Nihi project as proposed by Cara Flores Mays of Duk Duk Goose. Being involved with various projects, there are 2 questions... first, the viability of the project and second, the sustainability of the project. So I would like to speak to those concerns. When we talk about project viability, you really want to demonstrate that your project is going to be effective in what it does, be cost effective, and the great thing is that the Nihi project is innovative in that there is no product that exists in Guam in this form. The second question is regarding sustainability and usually when you look at funding, and the question is if we give you this seed money, how are you going to turn that project into a long-term commitment by the founders to ensure that the objectives of the project can continue into the future. Mr. Denight brought up a relevant point about how he was interested in being able to turn it into a cultural product. I think the Nihi project is a really good way to express that. It's a doable project because it has a revenue generation in terms of actually having products that are related to the show. The other thing about Nihi is that it is based on the Children's Television Network model, which was originally developed by Sesame Street and the Children's Television Network model has to do with evaluation, research and community support. I'm so grateful to be here and to have heard everybody else's testimony today and I really thank you very much for your support.

**Senator Muna Barnes:** You're very welcome... I'd like to open up for any comments or questions. Vice Speaker? Senator San Nicolas?

**Senator San Nicolas:** I'm really glad that you touched on those two items, viability and sustainability, and I'm glad that you acknowledge that this is seed capital and not as a sustainable revenue source. I have no doubt that the program is valid and necessary, what I'm really concerned is the sustainability of it because I want to make sure that when we capitalize something, it's important that it's going to succeed because especially on this island when we capitalize things and they fail, it becomes next to impossible to try to do it again. We did that

Maxx Havoc movie and when somebody talks about producing a movie on this island, everyone's like whoa... so I want this to work and I want to make sure the viability and sustainability aspect is fully vetted. Have you already developed a business plan for the program?

**Marie Ada Anyung:** We actually see this as a multi-year endeavor. We're looking at the seed money from TAF to fund a discreet number of series of 20 episodes specifically because when we have the episodes we can actually use that as a product, as a way to leverage other resources later on. As far as the business plan is concerned, we really trying to get the initial production done that is really what the TAF funding will fund. I don't know if that answers your question... we don't have a business plan in the sense that like a strategic plan, we can speak as to how we're going to get these episodes done.

**Cara Flores-Mays:** We do have a budget... it's a 2-year budget and so in terms of a business plan, we have a 2-year business plan. It's something that we're developing... the 3 to 5 year plan. I feel that what we have for the first 2 years is really strong so does that answer your question?

**Senator San Nicolas:** A little, but unfortunately not in a positive way... I mean what I'm looking for is if we pump in \$127,000 of our people's money and our people make that investment, do you have a strategy to convert that initial investment into a sustainable revenue generating, self-monetizing operation to continue the programming. I mean there are... or are we just buying 20 programs and we don't know what's going to happen after that?

**Cara Flores-Mays:** I think that as Marie mentioned, having 20 programs... we're in the process of identifying grants and that doesn't even consider private funding. Which there have been at least 4 larger companies that have approached and have expressed interest... we're just not at that point yet.

**Senator San Nicolas:** Could I get a copy of the business plan that you developed, and I guess you have a programming plan as well if you already have 20 programs projected?

**Cara Flores-Mays:** No, that's part of the process and ideas, but they're included in that production plan that is the writing of those episodes. For us, there have been hundreds of hours of writing devoted so I have a job, people have jobs so that funding we can't pay people to write the episodes and then pay production to produce them.

**Senator San Nicolas:** So basically you're asking for \$127,000 to capitalize on an idea and turn it into something.

**Cara Flores-Mays:** We have 3 episodes that we're going to run on PBS.

**Senator San Nicolas:** Are those full episodes or...

**Cara Flores-Mays:** Those are full episodes... what we showed today was a trailer using the 3 episodes that we have.

**Senator San Nicolas:** Could I see those 3 episodes?

**Senator Muna Barnes:** As oversight chair, I do have a copy of that and with permission I will share that with the committee members. I do want to note that all of our colleagues are part of that committee.

**Senator San Nicolas:** Thank you madam chair.

**Senator Muna Barnes:** With that being said any other questions? First and foremost I want to thank you for your presentation. I was very impressed Miss Marie... thank you. Okay, Bill No. 113-32 is publicly heard.

A recent "Time Magazine" cover was titled "The Me Me Me Generation and How They Will Save Us All. It goes on to talk about this generation's ways and use of technology. Nihi is a profound demonstration of the new generation alive and well on this Island. Many of who are children with parents from the 60's and 70's generation's movers and shakers. I must say, I am proud to be here on Guam at this time, to witness this new compelling vision for positive change. Nihi's creativity is incorporating ancient knowledge with a high level of professionalism, grace style and modern technology.

I am happy to say I have had the pleasure of watching Bernie and Mike Grajek's daughter, Andrea grow up. Over the years, she has used her talent and skills as an artist to contribute to her mom's on going work for people with disabilities at Guma Mami. Now Andrea has taken

those skills to a new level to pursue her own vision for this beautiful island she loves so dearly. Like the other young adults involved in this program, they want and need a healthy and happy Island of Guam for themselves and future generations. They want this island to be sustainable. They want a link to their proud ancient history. They have made it happen in a fun way. They use art and the modern day technology they grew up with. What tremendous hope and inspiration this vision and foresight, gives to us all.

The WHOLE ISLAND ought to get behind Nihi and support it, local Government, business and community partnerships. The military and Federal Government could do well by contributing funds and support to this creative work. I cannot help but think that giving these young visionaries a space of their own to create and work from, would be a positive step to support their honorable vision for Guam. These young people have shown the kind of initiative that deserves real action support with money included, not just nice flowery words.

I was at a children's mental health conference in Portland Oregon, ten years ago, just after the last typhoon in January 2003. We were there to learn about wraparound and how to provide services for children with serious mental health issues. I have not forgotten the panel of teens who presented there. Yes, they were troubled children, "extremely naughty ones", who had been stealing, abusing drugs, high school dropouts and homeless, you name it. All of them had mental health needs and were receiving multiple services. They were all asked, "What do you think helped you the most"? I was so surprised to learn how each one of them, described what their lives were like and how they talked about their need to belong. All of them said, "Really getting in touch with my culture gave me a place to feel I belonged. Learning the old ways, and the singing and dancing, gave me a deep connection to something that was missing." Their strength based multiple support services, included connecting them to their cultural roots, where they found that sense of belonging and acceptance. They were now able to feel proud of their culture, and that pride gave them a strong sense of self and self-esteem. They could give back to the community that they had embraced and now loved to help others.

Sadly not all children a blessed growing up in healthy family environments, many have parents working who are barely getting by being able to survive. Their parents may have little knowledge or time left for the any kind of involvement let alone of cultural importance. Nihi, would certainly help to fill that gap and could easily become an added dimension for the entire family to enjoy bonding together especially when Nihi's intention is:

1. Preserve and protect our unique language, culture, stories, identity, and resources
2. Instill a confidence and pride in our unique identity and our island community
3. Inspire a deep love for our water, land, and people
4. Promote sustainable and healthy ways of living

Nihi! is advocating for: Chamorro language and culture (the continuation of belonging)  
Character development (respect, kindness, honesty, work ethic, sharing and other culturally based values and traits). Environmental Stewardship, Health and Learning



I believe the Nihi program has the potential to give little ones that holistic connection early on in life, which may help prevent our island's children from feeling disconnected. A feeling which can contribute to suicide and Guam has a high suicide rate. Please do not think it will only be little ones who will be interested. There is no doubt that it will be a true blessing for Guam's generation who were not allowed to speak their language, who did not have the opportunity to fully embrace all of their culture and who could not fully pass it on to their children. Nihi is something all family can enjoy participating in. Nihi is something little ones can have a positive experience learning with. Nihi can be enjoyed at home with their grandparents. Nihi can be enjoyed anywhere with family members or others on the internet. Nihi is also a tool for an endearing learning opportunity for military families or others living on Guam or tourists visiting Guam. Non Chamorros who would like to learn and embrace this unique local ancient language and culture. What better easier way more practical way than this to enjoy leaning than this. Using local produce and products has a double learning advantage too. Nihi can only have lasting positive effects for the community.

I am taking a stand to support these young Guam adults and their work. How about you?

If you are a Filipino child, a Japanese child, a Korean, or Chinese child growing up on Guam, there are television programs for you, where you will see people who look like you, you will hear your native language, and your cultural values will be presented. If you are Chamorro child growing up here, Guam, I tano Chamorro, there are currently no programs to make you feel empowered by seeing, hearing, and learning your culture on television.

The children of Guam are growing up in a time when their parents are working multiple jobs, their grandparents are not able to retire, and the children spend hours with the attention glued to the television , ipads, and the home computer.

In conclusion, I fully support the efforts of the 'Guam Preservation Trust,' the 'Guam Council on the Arts and Humanities Agency,' the 'Government of Guam,' the 'Office of the Governor' and the 'National Endowment for the Arts' and allies to successfully manifest the "PBS" children's television program, "Nihi," which will 'empower the next generation as protectors of our resources and perpetuators of our language and culture.' Saina Ma'ase!

TO COVER PRODUCTION COSTS FOR A CULTURAL CHILDREN’S TELEVISION PROGRAM.”

The TAF provided approximately \$14 million to fund GVB, over \$1million to maintain the beach, \$530k to non-profits, \$1.3 million for FESTPAC and Folklife festivals, and approximately \$200,000 to GVB’s Rainy Day Fund. The TAF ended FY2012 with a \$1.3 million increase, the highest level of tax revenues received in over 10 years (*OPA Audit, April 2, 2013*).

In light of the generous appropriations the TAF administers for personnel, beach clean-up and ambassadorial festivals, due consideration must be made for funding *Nihi* and other worthwhile and sustainable local projects. Duk Duk Goose, Inc. is a non-profit that will be overseeing *Nihi* a children’s television series. The mini production promoted Chamorro language, culture and values through creative story- telling and acting. The values of respect for our people and our island were profoundly relayed in *Nihi* through the eyes and voice of our children. Producing *Nihi* and other laudable projects helps sustain our heritage. Tourists visit Guam to experience the culture- through the people and the land. *Nihi* is a true representation of Chamorro culture as depicted in the mini television series. Practicing the values of reciprocity, respect and family are portrayed in *Nihi* for families, guests and all to embrace.

Again, I ask you to revolutionize the messages we want to send our kids moving from the profane to the profound. Support culture by voting for Bill 113-32. *Si Yu’us ma’ase.*

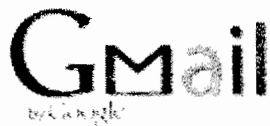



I am writing in support of bill 113-32, an act to add a new section 16 to Chapter X of public law 31-233, which would appropriate money from the Tourist Attraction Fund (TAF) to Duk Duk Goose, Inc. in order to cover the production costs for a cultural children's television program.

I believe that when we foster our island's children with a deeper sense of cultural pride, they grow to be more enthusiastic representatives of our island (both at home and afar). Currently, our island lacks CHamoru media, particularly CHamoru media created for our children. By funding Duk Duk Goose, Inc's project, you are helping to provide our youth with tools that will undoubtedly generate more interest in their unique heritage. In addition to our indigenous CHamoru children, having a children's show, such as the one proposed by Duk Duk Goose, will help other Guamanian children, who are not of CHamoru ancestry, to respect and value the traditions of the island they have chosen to make their home. It is important that all our visitors encounter residents who feel positively about this island and its culture.

The children of our island are raised with easy access to Filipino, Japanese, or Korean newspapers, radio shows, and television channels. Having access to a CHamoru children's show is an exciting and positive thing for our people and our visitors, who may be curious about our local culture. I have also found, through the selling of my CHamoru children's flashcards, that visitors are very eager to take home things specifically geared toward children. They are interested in showing the children where they are from what life is like for CHamoru and Guamanian children. Once again, thank you so much for supporting the film arts here in our community. Your work is appreciated very much!

As for my Public Testimony, here are my reasons for supporting and working on the Nihi show:

1.) We simply need positive TV. I feel bad for this young generation. They don't have the positive role models we had while growing up. Sesame Street has pretty much faded away. Mr. Roger's Neighborhood is gone for good, then reading rainbow and so on...So, the question is- What do our kids have now ?

I'm with Nihi because I love it's purpose, promoting things that are in desperate need of attention at the moment: culture appreciation, respect, human and environmental health.

One thing that I personally want to emphasize about Nihi, is that its a show that inspires it's young viewers to reconnect with our natural environment, teaching the true value of our natural resources and why we must protect it.

Just the other day, my grandpa was explaining to me how, back in his young days, people use to be able to drive along the old roads and grab banana bunches on the way home to feed their family. "If we were hungry, we'd just step in to the jungle and pick food, no body went hungry back in those days."...That statement concerned me, because, we can't do that in our jungles today! It only took two generations to lose that privilege of rich and fruitful vegetation.

Today, our coconut trees dying, breadfruit and banana trees have diseases. Our fish, our rivers...

What will become of our lands, two generations after us?

On another note, today's generation depends 100% on grocery stores and off island goods.

What happens when all importing to Guam suddenly stops?

We have some of the most powerful cancer fighting foods that can grow in our back yard, yet, many are quick to cut them down...

So as you can see, "an appreciation" for our natural resources needs immediate attention.

Nihi, works to bring back an appreciation for our natural wealth here in our lands and ocean. That is my reasoning in support of Nihi.

2.) A Senator commented on the budget and shared concerns about allowing funds for Nihi purposes--My response is as follows:

Here on Guam, there are a handful of people who are working very hard to inspire a new industry in the art of film for Guam, and the main reason they have to work so hard is because, "there is a lack of understanding and appreciation for the film arts here." We need real incentives for this sort of industry to really take off.

Right now, here on island, film/video is still looked upon as a "hobby" and NOT as a true career choice. If you visit the industry in Hawaii, Thailand, Hollywood, Japan, P.I., Korea, China, its the other way around; those communities have a thriving film/video industry which provides many additional career incentives.

Observe the film credits after a movie, its big business and Guam can have that.

Although, its a small crew, Nihi is providing jobs which cater to local artists; therefore, the money from the TAF fund, will stay and circulate within our economy and it will inspire opportunity for local artists.

Please understand, that the budget requested is very small.

Anyone in the industry will tell you that \$100K is not considered a big budget for anything in film or television; \$100K is the going rate for a quality, 2 to 3 minute, music video or a 1 minute commercial, which, are productions that may last two weeks.

Also, to put the film industry in to perspective, there is a current budget in talks to fund a film for \$1 million + film production, that may take about 30 days to complete...

Nihi is going in to production for a full year, with 12 plus episodes in line, each at 27 minutes in length per episode...\$100K is small funding for a TV show series.

In conclusion, the TAF fund can open doors for other productions alike by inspiring incentives for both "Positive TV" and "New Industry Development" here on island.

Håfa Adai. My name is Kisha Ann Borja-Quichocho, and I am a Chamoru daughter of Guåhan. I was born and raised on this island, yet I cannot speak the language of my ancestors fluently. Over the years, my inability to fluently speak, understand, and write in fino` Chamoru has damaged more than just my confidence; it has damaged my cultural identity. While I am learning Chamoru now, I have already lost so much because I was not taught the language since I was a child.

When my elders speak to me in Chamoru, I can understand most of what they are saying, yet my responses are always in English. When people ask me if I can speak Chamoru, I always tell them, "Didide". When I went to school and lived in Hawai`i for 6 years, I would have opportunities to share the Chamoru culture and would be able to share information about the history, food, chants, and dances, but I could never share much about the language and thus always felt mamahlao.

Though I paint a bleak image for my situation, I still have hope. Hope for Chamorus of my generation. Hope for future generations of Chamorus and non-Chamorus. I have hope for several reasons. First, we still have manamko` who are speaking our language and who continue to pass down stories to us in Chamoru. Second, Chamoru is taught in our education system (from elementary to the university level). Third, several non-profit organizations and grassroots organizations exist to teach the Chamoru language and other parts of the Chamoru culture. These reasons provide hope for the Chamoru people because they allow us to see ourselves alive, thriving in a place that has become so developed and that often forgets to put Chamoru at the forefront.

Here on Guåhan, we always say that we're proud of who we are and where we come from. But how can we continue to instill and possess this pride if we fail to teach and learn it? Funding and other types of support from the various facets of our community are necessary if we are to continue to perpetuate our culture for years to come.

We have to support projects such as "Nihi!", for ourselves, and even more so, for our children. I am going to be a mother very soon, and I can't imagine keeping any part of our beautiful culture from my neni. S/he has the right to know where s/he comes from, the right to learn and know fino` Chamoru, the right to a more complete cultural identity. If we fail to fulfill our responsibilities, our cultural obligations, then where would that leave our children, the future state of our culture and island?

**Comments on Bill No. 113-32 (COR)**

The bill is seeking to appropriate a total of \$127,000 from the Tourist Attraction Fund to Duk Duk Goose Inc. to cover the cost of producing episodes for a cultural children's television program.

Duk Duk Goose Inc. had produced sample/pilot episodes of their children's program entitled *Nihi* which showcases preservation and protection of the island's language, culture, land and stories. The intent of the funding is to provide funding for the production of several program episodes which will be used to promote and benefit the tourism industry to provide information to our tourist and potential visitors. The bill also notes long term benefits in providing the programming to our elementary school students.

The bill allows for the funds to be used until expended and require for reporting requirements as noted in Public Law 31-233.

Based on the FY2012 released audit by the Office of Public Accountability for the Tourist Attraction Fund (TAF) FY2012, the Fund Balance amount is \$4,065,015. The current status of the TAF reflects revenues as tracking positively.

**Comments on Bill No. 113-32 (COR)**

The bill is seeking to appropriate a total of \$127,000 from the Tourist Attraction Fund to Duk Duk Goose Inc. to cover the cost of producing episodes for a cultural children's television program.

Duk Duk Goose Inc. had produced sample/pilot episodes of their children's program entitled *Nihi* which showcases preservation and protection of the island's language, culture, land and stories. The intent of the funding is to provide funding for the production of several program episodes which will be used to promote and benefit the tourism industry to provide information to our tourist and potential visitors. The bill also notes long term benefits in providing the programming to our elementary school students.

The bill allows for the funds to be used until expended and require for reporting requirements as noted in Public Law 31-233.

Based on the FY2012 released audit by the Office of Public Accountability for the Tourist Attraction Fund (TAF) FY2012, the Fund Balance amount is \$4,065,015. The current status of the TAF reflects revenues as tracking positively.




*I Liheslaturan Guåhan* further finds that in 2012, Duk Duk Goose, Inc. produced three (3) sample/pilot episodes of a children's program, entitled *Nihi*, which beckons viewers to new adventures of learning fun. In January of 2013 Duk Duk Goose, Inc. held a private viewing for a test group of parents and children. The production of these sample episodes were partially funded by the Guam

4 **Section 2. A New Section 16 is hereby added to Chapter X (Guam**  
5 **Visitors Bureau) of Public Law 31-233 to read:**

6 **“Section 16. Appropriation to Duk Duk Goose, Inc.** The sum  
7 of One Hundred Twenty-Seven Thousand Dollars (**\$127,000**) is hereby  
8 appropriated from the Tourist Attraction Fund (TAF) to Duk Duk Goose,  
9 Inc. to cover production costs for a cultural children’s television program.  
10 The funding authorized herein shall be used specifically by Duk Duk Goose,  
11 Inc. towards the cost of production coordination; scripting and research for  
12 each episode; and production talent and set materials. Notwithstanding the  
13 general provisions of §30107.1 of Chapter 30, Title 11 GCA, and this Act,  
14 this appropriation *shall* continue to be available until expended. The  
15 provisions contained in Section 14 (Service and Reporting Requirements) of  
16 Chapter X of Public Law 31-233 *shall* be applicable.”

17 **Section 3. Effective Date.** The provisions contained herein shall take  
18 effect immediately upon the enactment of this Act.
