

AN ACT TO *ADD* A NEW SUBSECTION (e) TO § 8121 OF ARTICLE 1, CHAPTER 8, TITLE 4, GUAM CODE ANNOTATED, RELATIVE TO ESTABLISHING PARITY IN THE RETIREMENT ANNUITY OF THE ATTORNEY GENERAL OF GUAM AND THE PUBLIC AUDITOR OF GUAM.

BE IT ENACTED BY THE PEOPLE OF GUAM:

Section 1. A new Subsection (e) is hereby *added* to § 8121 of Article 1, Chapter 8, Title 4, Guam Code Annotated, to read:

“(e) Any person who is elected to the Office of the Attorney General of Guam or the Office of Public Accountability, and who is retired from the government of Guam and receiving benefits, *shall not* relinquish, forfeit, or

1 have such annuity suspended during the period of serving in such elected
2 office.”

3 **Section 2. Effective Date.** This Act *shall* be effective upon enactment.
