**AN ACT TO APPROPRIATE FUNDS FROM THE
FISCAL YEAR 2014 HOTEL OCCUPANCY TAX (HOT)
SURPLUS FUND FOR THE PAYMENT OF CAPITAL
NEEDS OF THE GUAM MEMORIAL HOSPITAL
AUTHORITY.**

1 **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2 **Section 1. Legislative Findings and Intent.** *I Liheslaturan Guåhan* finds
3 that there exists Three Million Five Hundred Thousand Dollars (\$3,500,000) in the
4 Fiscal Year 2014 Hotel Occupancy Tax Surplus Fund available for appropriation.

1 **Section 2. Appropriation.** Notwithstanding any provision of law, the
2 sum of One Million Six Hundred Thousand Dollars **(\$1,600,000)** is hereby
3 appropriated from the Fiscal Year 2014 Hotel Occupancy Tax Surplus Fund to the
4 Guam Memorial Hospital Authority for the purchase of a Computerized Axial
5 Tomography (CAT) Scan machine and related supplies. Notwithstanding the
6 general provisions of § 30107.1, of Chapter 30, Title 11 GCA, this appropriation
7 *shall* continue to be available until expended and is *not* subject to transfer or use
8 for any other purpose.
