Re: Bill No. 391-35 (LS) – An Act to Cancel the 2020 Primary Election and to Provide for a Safer 2020 General Election

Dear Madame Speaker,

Just as we know the Guam Election Commission did not easily arrive at the decision to recommend cancelation of the primary election, I understand that reaching this determination was equally difficult for the Legislature. Every election matters. And the people who participate in our elections should never feel as though their decision to exercise their right and perform their civic duty is without value. However, I sign Bill 391, now known as **Public Law No. 35-96**, because I agree with the Commission and the Legislature that at this point in our history, the bigger, more consequential decision we must make is the one to save lives.

I know that the Commission has already begun the planning necessary to ensure a safe general election, and I will support that effort in any way I reasonably can. But, as you know, many of the support services ordinarily utilized during an election are critical to the monumental effort made every day to respond to our current public health emergency. It is, therefore, my hope that the Commission will encourage voters to utilize the early and absentee voting allowances that P.L. No. 35-96 provides, so that we can all safely







**AN ACT RELATIVE TO CANCELLING THE 2020
PRIMARY ELECTION AND PROVIDING FOR A SAFER
2020 GENERAL ELECTION.**

1 **BE IT ENACTED BY THE PEOPLE OF GUAM**

2 **Section 1. Legislative Findings and Intent.** *I Liheslaturan Guåhan* finds
3 that due to the recent spike in COVID-19 cases on Guam, the Guam Election
4 Commission is unable to hold the 2020 Primary Election without jeopardizing the
5 health, safety, and welfare of the people of Guam. The Guam Election Commission

1 informed *I Liheslatura* that due to *I Maga'hågan Guåhan*'s declaration of Pandemic
2 Condition of Readiness (PCOR) 1, it is uncertain if logistical arrangements needed
3 prior to the 2020 Primary Election can be executed. Furthermore, while *I*
4 *Liheslaturan Guåhan* has voted down a similar measure previously during PCOR 2,
5 due to an increase in mortality rates, confirmed cases, and hospitalizations due to
6 COVID-19, it is no longer feasible to hold the 2020 Primary Election as the health,
7 safety, and welfare of an estimated 16,410 to 19,145 residents may be subject to
8 undue risk. While the Guam Election Commission previously testified that it was
9 capable of holding the 2020 Primary Election, the Guam Election Commission
10 Board has informed *I Liheslaturan Guåhan* that this is no longer the case. *I*
11 *Liheslaturan Guåhan* also notes that given the uncertainty regarding COVID-19,
12 immediate steps need to be taken to ensure that safeguards are put in place to ensure
13 that the 2020 General Election can proceed.

14 **Section 2. Cancellation of the 2020 Primary Election.** Notwithstanding
15 any other provision of law, or rule or regulation, the 2020 Primary Election shall be
16 canceled, and all qualified candidates for the 2020 Primary Election shall advance
17 to the 2020 General Election.

18 **Section 3. Personal Delivery of Ballot for 2020 General Election.**
19 Notwithstanding 3 GCA § 10107, the Guam Election Commission shall deliver a
20 ballot to any qualified elector applying in person at the office of said Commission,
21 provided that such applicant shall complete and subscribe the application heretofore
22 prescribed by 3 GCA Chapter 10; provided however, that said application shall be
23 made not more than forty five (45) days nor less than one (1) day before the date of
24 the election for which the vote is being cast. It is provided further, that said ballot
25 shall be immediately marked, enclosed in the ballot envelope, placed in the return
26 envelope with the proper affidavit enclosed, and immediately returned to the
27 Commission. This provision shall apply only to the 2020 General Election.

1 **Section 4. Permitting Absentee Voting for All Qualified Voters.**

2 Notwithstanding 3 GCA § 10101, any qualified voter of Guam may vote in the 2020
3 General Election during the forty-five (45) day in-office absentee voting period as
4 provided for under this Act.

5 **Section 5. Safety Plan for 2020 General Election.**

6 Notwithstanding any other
7 provision of law, rule or regulation, the Guam Election Commission shall adopt a
8 resolution detailing the Commission’s safety measures and mitigation efforts to ensure a
9 safe 2020 General Election. The resolution may also include recommendations for
10 alternative voting practices, including but not limited, to mail-in voting or voting centers
11 for the 2020 General Election for legislative action. The Director of the Guam Election
12 Commission shall transmit said resolution to the Speaker of *I Liheslaturan Guåhan* no later
13 than September 14, 2020.

13 **Section 6. Logistical Support.**

14 The Governor may, to the extent
15 practicable, provide logistical support and resources, including the detailing of any
16 government personnel as needed, to the Guam Election Commission in order to
17 ensure a safe and successful 2020 General Election.

17 **Section 7. Severability.**

18 If any provision of this Act or its application to any
19 person or circumstance is found to be invalid or contrary to law, such invalidity shall
20 not affect other provisions or applications of this Act that can be given effect without
21 the invalid provision or application, and to this end the provisions of this Act are
severable.

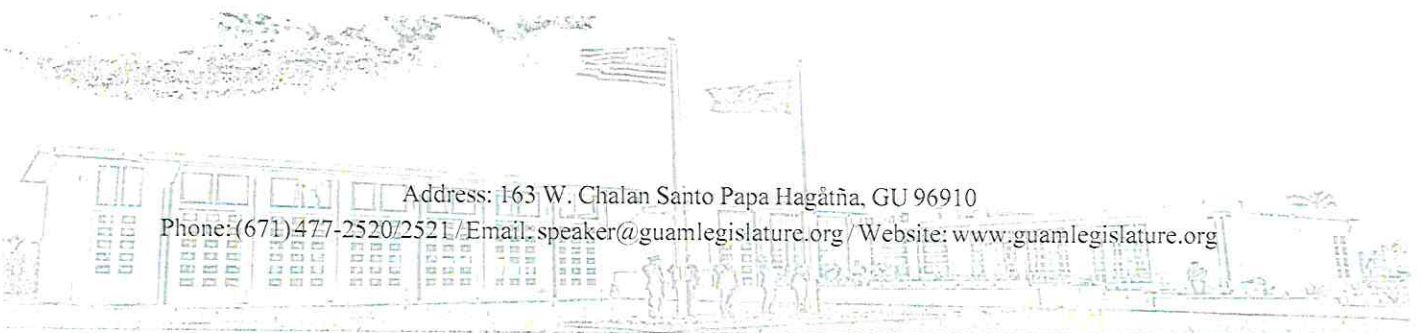

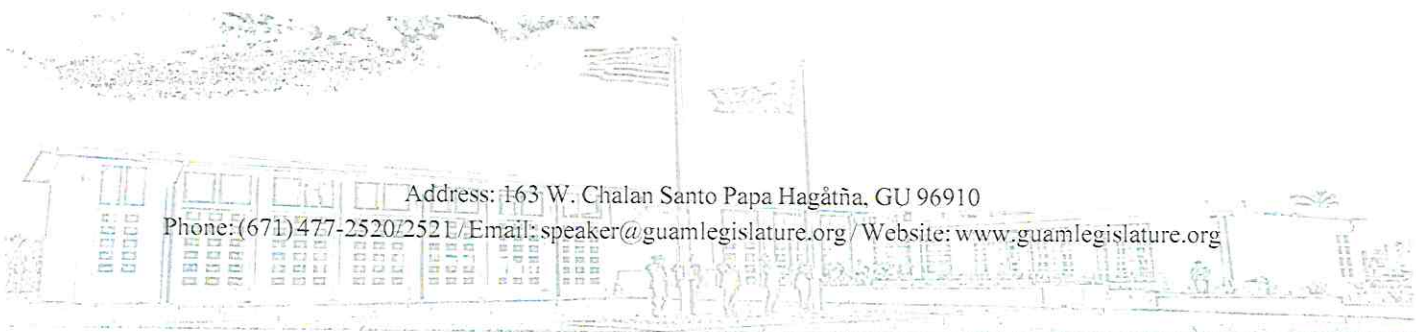
