AN ACT TO *AMEND* §3103 OF CHAPTER 3, TITLE 7,
OF THE GUAM CODE ANNOTATED RELATIVE TO
ADDING A SUCCESSIVE TERM OF SERVICE FOR
THE CHIEF JUSTICE OF THE SUPREME COURT OF
GUAM.

BE IT ENACTED BY THE PEOPLE OF GUAM:

Section 1. Subsections (j) and (k) of §3103, Chapter 3, Title 7, of the Guam Code Annotated, are hereby amended to read:

“(j) ~~No Justice may succeed himself or herself as Chief Justice.~~ A Chief Justice may serve a maximum of two (2) successive terms, and may not again be eligible to hold that position until one (1) full term has intervened.

(k) When a Chief Justice completes his or her ~~term~~ term(s) as Chief Justice, he or she shall continue to sit as a full-time Justice of the Supreme Court, until his or her term as Justice expires.”

Section 2. Effective Date. This Act shall be effective upon enactment.
