## AN ACT RELATIVE TO REPEALING AND REENACTING SECTION §9108 OF TITLE 16 GUAM CODE ANNOTATED.

**BE IT ENACTED BY THE PEOPLE OF GUAM:** 1 Section 1. §9108 of Chapter 9 of Title 16, Guam Code Annotated, is 2 3 hereby *repealed and re-enacted* to read as follows: § 9108. Violation of This Title - Petty Misdemeanor. 4 Except in cases where a different punishment is provided by this Title, 5 6 every person who fails or refuses to comply with or violates any provision of this Title is guilty of a petty misdemeanor. 7 "§9108. Violation of This Title – Violation 8 9 (a) Except in cases where a different punishment is provided by this Title or other law, every person who fails or refuses to comply with or 10 violates any provision of this Title is guilty or liable of a civil violation 11 12 punishable by a fine as set forth at law or in the schedule of fines adopted by 13 the Traffic Court Division of the Superior Court of Guam or by the Judiciary Branch of the government of Guam, or if fine amount is not enumerated at 14

law or in the schedule of fines above, then fine amount is not to exceed Five
Hundred Dollars (\$500.00).

3 (b) Notwithstanding subsection (a) of this Section, the Office of the 4 Attorney General is not precluded from filing a criminal complaint or 5 indictment pursuant to Chapters 15, 45 and 50 of Title 8 G.C.A. in the 6 Superior Court of Guam that may include charges involving the violation of, 7 or failure or refusal to comply with any provisions of Title 16 G.C.A."
