## AN ACT TO AMEND §4402 OF CHAPTER 4, TITLE 4, GUAM 1 CODE ANNOTATED, RELATIVE TO THE MEETINGS OF THE 2 **CIVIL SERVICE COMMISSION** 3 **BE IT ENACTED BY THE PEOPLE OF GUAM:** 4

Section 1. Section §4402 of Chapter 4 of Title 4, Guam Code Annotated is 5 6 hereby *amended* to read:

"§4402.Quorom and Deliberations 7 The quorum of the Commission shall be four (4) members. Meetings 8 of the Commission shall be conducted in accordance with the Open 9 Government Law except that any and all deliberations of the Commission 10 may occur in a closed session and no transcript of such deliberation need be 11 maintained, nor shall the Commission be required to record such 12 deliberation. When conducting such closed deliberations, only members of 13 the Commission board, along with the Commission's counsel and its 14 Executive Director may be present. No action may be taken by the 15 Commission during such closed deliberation and voting must occur in open 16 session. The affirmative vote of four (4) members shall be required for any 17 action of the Commission and such vote must be conducted in an open, 18 public meeting. The Commission may adopt rules to govern its procedures 19 20 and the standards maintained by non-attorney representatives; provided, that 1

rules adopted by the Commission shall recognize that representative is not
an attorney and cannot be bound by the same standards and ethics as an
attorney; and, further, provided, that in cases where an employee represents
oneself, the Commission shall render all possible assistance to the employee
to insure a fair and impartial hearing."
