AN ACT TO ADD A NEW §1115 TO CHAPTER 1 OF TITLE 12 OF THE GUAM CODE ANNOTATED; RELATIVE TO PROVIDING NO COST SPACE TO THE GUAM CUSTOMS AND QUARANTINE AGENCY IN A MANNER CONSISTENT WITH FEDERAL LAW

BE IT ENACTED BY THE PEOPLE OF GUAM:

Section 1. A new section §1115 is hereby added to Chapter 1 of Title 12,

Guam Code Annotated to read:

"§1115. No Cost Space to the Guam Customs and Quarantine Agency

The airport shall provide, without cost to the Guam Customs and Quarantine Agency, proper office and other space reasonably needed for the regular operations of the agency, and the sole use of Customs and Quarantine officials working at the airport."

Section 2. Effective Date. This Act shall be effective upon enactment.
