AN ACT TO REZONE LOT NOS. 2 AND 3 OF TRACT 1419, LOCATED IN THE MUNICIPALITY OF DEDEDO, FROM AGRICULTURAL ZONE (A) TO COMMERCIAL ZONE (C).

BE IT ENACTED BY THE PEOPLE OF GUAM:

Section 1. Legislative Findings and Intent. *I Liheslaturan Guåhan* finds that it is the desire of the owners of Lot Nos. 2 and 3 of Tract 1419, which fronts Tun Columbo St. (Alegeta Road) in Macheche, to own and operate a mom-and-pop store for the retail of food and other general merchandise.

I Liheslaturan Guåhan further finds that the owners propose to utilize the two thousand four hundred and fifty (2,450) square foot first floor of the existing two-story building located on the property for the operation of the convince store.

Therefore, to assist the owners in servicing those who live and commute the Macheche/Alegeta road vicinity, *I Liheslaturan Guåhan* intends to authorize the rezoning of the lots described herein for the operation of a mom-and-pop store.

Section 2. Lot Rezoning. Notwithstanding any other provisions of law,
Lot Nos. 2 and 3 of Tract 1419, containing an area of 1,861+/- square meters,
located in Macheche in the Municipality of Dededo, is hereby rezoned from
Agricultural Zone (A) to Commercial Zone (C).

Section 3. Effective Date. This provisions contained herein shall take effect immediately upon enactment of this Act.

SECTION 4. Severability. If any of the provisions of this Act or the application thereof to any person or circumstance is held invalid, such invalidity *shall* not affect any other provision or application of this Act which can be given effect without the invalid provision or application, and to this end the provisions of this Act are severable.
