**AN ACT TO AMEND PUBLIC LAW 31-235, RELATIVE TO THE
WOMEN'S REPRODUCTIVE HEALTH INFORMATION ACT OF 2012.**

1 **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2 **Section 1. Legislative Findings and Intent.** *I Liheslaturan Guåhan* finds under
3 the provisions set forth in Title 5, Chapter 9, Article 3 of the Guam Code
4 Annotated, that “printed materials” and “checklist certification” are not “rules” or
5 “regulations” as defined therein. The information required under Public Law 31-
6 235 are reduced to a distributable form. Thus, the requirement that they be
7 subjected to legislative review will further delay the implementation of the law and
8 previously referenced by I Magalåhen Guåhan in his transmittal letter dated
9 November 06, 2012 to the Speaker of *I Liheslaturan Guåhan* .

10 It is the intent of *I Liheslaturan Guåhan*, to amend by deleting the provisions set
11 forth in Section 4. Effective Date. of Public Law 31-235 pertinent to the ‘*Women’s*
12 *Reproductive Health Information Act of 2012,*’ as to remain consistent with the
13 original intent of the Act.

14 **Section 2. Deletion of Section 4. Effective Date. from Public Law 31-235**

15 Section 4. of Public Law 31-235, is hereby deleted in its entirety.
