BE IT ENACTED BY THE PEOPLE OF GUAM:

Section 1. §22425(q)(4) and (q)(5) of Article 4, Chapter 22, Division 2, Title 5, Guam Code Annotated is hereby amended:

“(4)The sum of One Million Seven Hundred Seven Thousand Six Hundred Fifty Two Dollars (\$1,707,652) to the Facilities and Maintenance Division of the Guam Department of Education for supplies and equipment for the maintenance of the GDOE Schools ~~the Okkodo High School Expansion to included rental, prorated insurance, maintenance and utilities.~~ All funds under this item shall not be used for other purposes ;

(5) Other than the portions designated to be used for in items (1), (2) , (3) and (4) of this subsection, eighty percent (80%) of the remaining balance shall be a appropriated as a source of payment for; a General Obligation bond secured for the replacement, or renovation of, Simon Sanchez High School to include its athletic
