6	(a) The holidays of Guam are:

8	Martin Luther King, Jr. Day, the third Monday in January;
9	Guam Discovery Day, the first Monday in March;
10	Memorial Day, the last Monday in May;
11	Independence Day, July 4th;
12	Liberation Day, July 21st;
13	Labor Day, the first Monday in September;
14	All Souls' Day, November 2;
15	Veterans' Day, November 11;
16	Thanksgiving, the fourth Thursday in November;
17	Our Lady of Camarin Day, December 8; and

(b) Whenever a holiday listed in Subsection (a) of this Section falls on a
Saturday or Sunday, the government of Guam shall follow the Federal government's
practice for that holiday.

(c) In addition to the holidays specified in Subsection (a) of this Section, *I Maga'lahen Guåhan* may declare by Executive Order additional non-permanent
holidays for special purposes. No holiday declared by Executive Order shall be
continued beyond the year in which the Executive Order is issued.

9 (d) Notwithstanding any other provision of law, no Government of Guam 10 employee shall be entitled to holiday pay for working on *Discovery Day*. Government 11 of Guam employees required to work on *Discovery Day* shall be given one (1) day off,

12 at the employee's option, during the two-week prior to or after *Discovery Day*.
