AN ACT TO AMEND SECTIONS 2(d) AND 2(g) OF PUBLIC LAW 31-229 RELATIVE TO SCHOOL FACILITIES LOCATED IN TIYAN.

1 BE IT ENACTED BY THE PEOPLE OF GUAM:

2 Section 1. Section 2(d) of Public Law 31-229 is hereby amended to read as
3 follows:

(d) School facilities or school(s) shall mean those public school facilities

5 located in Tiyan, including land, improvements, and equipment, selected by the
6 Department of Education for renovation, expansion, and rehabilitation pursuant to this
7 Act. School facilities *shall* also mean and include any land, improvements,
8 administrative offices, equipment, and facilities located in Tiyan that serve and benefit
9 education.

10 Section 2. Section 2(g) of Public Law 31-229 is hereby amended to read as follows:

(g) *Facility shall* mean and include any school facility, and any other real and/or personal property, land or building owned, leased, used or controlled by the government of Guam <u>located in Tiyan.</u>
