AN ACT RELATIVE TO APPROPRIATING THE FUNDS IN THE GMHA HEALTHCARE TRUST AND DEVELOPMENT FUND TO THE GUAM MEMORIAL HOSPITAL AUTHORITY PURSUANT TO PUBLIC LAW 32-060; BY AMENDING SUBSECTION "(B)" OF §97103, CHAPTER 97, ARTICLE 1, TITLE 10, GUAM CODE ANNOTATED.

### BE IT ENACTED BY THE PEOPLE OF GUAM:

- 2 Section 1. GMHA Healthcare Trust and Development Fund Appropriation.
- 3 Subsection "(b)" of §97103 of Chapter 97, Article 1, Title 10, Guam
  - Code Annotated, is hereby amended to read as follow:
    - "(b) Up to forty percent, of the funds in the GMHA Healthcare Trust and Development Fund, *shall* be allocated to the Guam Memorial Hospital Authority for the purpose of subsidizing its delivery of healthcare services. The fees collected pursuant to this item (b) *shall* be **annually allocated and** is hereby appropriated, and shall continue to be deemed appropriated, annually, to the Guam Memorial Hospital Authority for the sole and specific purposes outlined below: subject to appropriation by *I Liheslaturan Guåhan* and may be used specifically for the following purposes:
