**AN ACT TO REPEAL AND REENACT §3105, CHAPTER
3 OF TITLE 22 OF THE GUAM CODE ANNOTATED
RELATIVE TO RESPONSIBLY RAISING THE
MINIMUM WAGE**

BE IT ENACTED BY THE PEOPLE OF GUAM:

Section 1. §3105, Chapter 3 of Title 22 of the Guam Code Annotated is hereby *repealed* and *reenacted* to read:

“§3105. Minimum Wages.

Every employer *shall* pay each person employed by him wages at a rate not less than Eight Dollars and Twenty Cents (\$8.20) per hour, effective January 1, 2015, Nine Dollars and Fifteen Cents (\$9.15) per hour, effective January 1, 2016, and Ten Dollars and Ten Cents (\$10.10) per hour, effective January 1, 2017.”
