### AN ACT TO REZONE LOT NO. 14NEW, BLOCK NO. 16 IN THE MUNICIPALITY OF DEDEDO FROM MULTI-FAMILY DWELLING (R-2) TO COMMERCIAL (C).

### BE IT ENACTED BY THE PEOPLE OF GUAM:

Section 1. Notwithstanding any other provision of law, the following
 lots as described below are hereby rezoned from Multi-Family Dwelling (R 2) to Commercial (C):

4 (a) Lot No. 14NEW, Block No. 16, in the municipality of Dededo,
5 containing an area of 1,188 square meters, referenced to
6 map filed under Document No. 100379, C.T. No. 77567;

7 Section 2. Effective Date. This provision contained herein shall take
8 effect immediately upon enactment of this Act.

9 Section 3. Severability. *If* any provision of this Act or its application 10 to any person or circumstance is held invalid, the invalidity *shall not* affect 11 other provisions or applications of this Act which can be given effect 12 without the invalid provision or application and to this end the provisions of 13 this Act is severable.
