BE IT ENACTED BY THE PEOPLE OF GUAM:

Section 1. Notwithstanding any other provision of law, the following 1 lots as described below are hereby rezoned from Multi-Family Dwelling (R-2 2) to Commercial (C): 3 4 Lot No. 16, Block No. 16, in the municipality of Dededo, containing an area of 1,127.60 square meters, referenced to 5 map filed under Document No. E4-55T343, C.T.
