AN ACT TO AMEND SECTION 12 TO CHAPTER X OF PUBLIC LAW 32-068 (GENERAL APPROPRIATIONS ACT OF 2014) MAKING AN APPROPRIATION FROM THE TOURIST ATTRACTION FUND (TAF) TO GVB FOR THE HUMATAK FOUNDATION.

1 BE IT ENACTED BY THE PEOPLE OF GUAM:

Section 1. Legislative Findings and Intent.

I Liheslaturan Guåhan finds that as a government, that as a government, we must do our part in an effort to preserve and protect our unique language, culture, stories, identity, and resources; instill a confidence and pride in our unique identity and our island community; inspire a deep love for our water, land, and people; and promote sustainable and healthy ways of living.

8 *I Liheslaturan Guåhan* further finds that revenue estimates for the Tourist 9 Attraction Fund (TAF) for Fiscal Year 2014 are tracking at Twenty-Nine Million 10 Eight Hundred Eighty Thousand Nine Hundred Forty-Four Dollars (**\$29,880,944**), 11 of which Twenty-Eight Million Five Hundred Thousand Dollars (**\$28,500,000**) is 12 appropriated.

I Liheslaturan Guåhan further finds that the TAF revenues for Fiscal Year
 2014 are projected to exceed appropriations by One Million Three Hundred Eighty

Thousand Nine Hundred Forty-Four Dollars (\$1,380,944) and is available for
 appropriation.

3 Section 2. Section 12 of Chapter X (Guam Visitors Bureau) of Public
4 Law 32-068 is amended to read:

5 "Section 12. Appropriation to GVB for Humåtak Foundation. The sum

6 of Fifty Thousand Dollars (\$50,000) Seventy-Five Thousand Dollars

7 (\$75,000) is appropriated from the TAF to the GVB for Fiscal Year 2014 for

8 operations of the *Humåtak* Foundation for the purpose of the operation of a

9 heritage museum at the former F.Q. Sanchez Elementary School.

10 Notwithstanding the general provisions of § 30107.1, of Chapter 30, Title 11

11 GCA and this Act, this appropriation *shall* continue to be available until

12 expended."

13 Section 3. Effective Date. The provisions contained herein shall take 14 effect immediately upon the enactment of this Act.
