# AN ACT REQUIRING THE COMPLETION OF AN INDEPENDENT ECONOMIC IMPACT STATEMENT RELATIVE TO THE MINIMUM WAGE ON GUAM.

#### **1 BE IT ENACTED BY THE PEOPLE OF GUAM:**

Section 1. Independent Economic Impact Statement. The Director of the Department of Labor *shall* be required to issue a Request for Proposal to conduct a one (1) year Independent Economic Impact Statement, relative to the Minimum Wage on Guam, no later than January 1, 2016. The results of the Independent Economic Impact Statement shall be made available within six (6) months from the date of completion and transmitted to the Speaker of *I Liheslaturan Guåhan* within thirty (30) calendar days.

9 Section 2. Funding for Independent Economic Impact Statement. I
