





Over the past year I've had the pleasure and the honor to serve in this board and to get to know a lot of different people not just on the board, but also the management team at the airport and the rank and file of the airport and for the past thirteen months, I've become very impressed with the operations at the airport. The individuals there that work day in and day out working to ensure the safety and comfort not just for our passengers and residents, but also all of the travelers in and out of Guam. The airport serves as the economic engine for our island, with our reliance on tourism and the military. The airport serves a crucial role in tourism, bringing all of our tourist in and out, and as many people have said, we are the first contact and first impression for all of our travelers coming in.

During the past year I've seen all the projects that are undergoing and under consideration and I am impressed and sometimes overwhelmed at the amount of work the goes on at the airport. Ultimately the goal is to modernize our airport so that we are a leader in the region and today we are a leader in the region as far as airports go. As Mr. Ada has mentioned, over the last four years we have been awarded a clean audit by the Public Auditor in examining our books. This past year, we were awarded, for the first time in the region, a perfect score by the FAA upon our annual inspection for certification. It's the first this airport, or any airport in the region including Hawaii a much larger airport, was awarded a perfect score. That's really attributed to the dedication of management and the rank in file staff. That's why I am here and I'm honored to be asked to serve, because I've sent the hard work done and I want to be a part of that. I want to able to help modernize our airport to make sure it's a safe and comfortable environment.

Senator Lee as far as some of the questions you brought up regarding the food court as Director Sobti has mentioned, there will be a massive food concession that will going out in a short time. When that goes out certainly that will be the time for us to take a look and see when we go through the bidding process and lay out some of the things that we want to see in that new food concession to include more local options, something that is more representative of our culture, maybe more healthy choices. We want our people to have a selection, not just different Asians foods and local foods, but also healthy foods.

As far as the arts, part of the budget for the third and fourth quarter under law is that one percent of our cost will go towards our cultural aspect, certainly we will be looking for, as we get further into that project, ways how we can showcase our local culture throughout the airport so our visitors have a sense when they are coming in and when they are leaving that they are actually in an island airport, a paradise airport. Those are some of the things that we are looking at. And as I mentioned, there are so many projects that are undergoing right now with parking structures and with the ARFF Facility. There's a lot of moving parts and I hope that if you are to extend my nomination and approve me to serve on the board those are things that I would like to work on in the next three years. Thank you.

Thank you very much Mr. Duenas. You are absolutely right; speaking of the heart certainly is reflective of your knowledge and expertise with regards to the airport authority. I know that you served on the GEDA Board and you had a lot of success over there so we're glad that you're able to continue your service and Thank you so much for accepting the Governor's appointment to this post and we look forward to confirming you.

You mentioned safety, safety was the first thing that you alluded to, so I wanted to ask what your thoughts are about any safety challenges that we have at the airport and how the Board under your leadership and with the hard work of Mr. Ada and his team are working to address any of the safety challenges.

Mr. Ricardo Duenas

Well first of all, you have to understand that at the airport obviously safety is mission one. We are operating the situation where the lives of thousands of people each day are in our hands, whether it's from the flight coming in, the processing of our visitors, through clearances, individuals coming to pick up passengers once they get off the plane, the securing of our boarders within the airport to ensure that everything is safe. We place a lot of emphasis on two particular entities, our Airport Police and Fire and Rescue. We hold them to high standards, we make sure they are adequately trained and given the resources to successfully carry out their mission within the airport. As far as in the airport terminal itself, we make sure that our facilities are within the mandates of the Transportation Safety Administration as well as the FAA and Customs Border Patrol, making sure our passengers are secured and in a sterile environment. We make sure that we anticipate any contingency and have plans and back of plans to address those situations. So when you say what are doing as far as ensuring safety, the safety concern permeates our operation throughout our operation, from the police to the fire department, to safety at the gates, to making sure our passengers know where to go, how to get there and how to get there safe and in a reasonable manner. It's really throughout the whole organization and I hope that answers your question.




